- 3. Your application must be submitted via email to receive consideration.
- 4. Subject of Email should state "Rental Assistance- First Name Last Name" (example: Rental Assistance- Jane Doe)

Online applications will be accepted starting March 1, 2022, Monday-Friday from 9:00 a.m. to 5:00 p.m. (EDT) through September 2022. Applications will be processed on a first come first served basis. This is a time limited program, and all awards are subject to the continued availability of funding.
