The first month's service fee and applicable roll cart fee <b>MUST</b> be paid in person at the Sanitation Division's administration building, 3720 Leroy Scott Drive, Decatur, Monday through Friday, 9 a.m. through 3 p.m. <b>Please make checks payable to the DeKalb County Sanitation Division</b> .
