Residential Collection Procedures

Household garbage - must be placed in secure, durable plastics bags. Households with larger capacity 95-gallon roll carts **must** ensure garbage bags are placed inside the cart; **no excess garbage is permitted outside the roll cart.** Households with 35-, 45- or 65-gallon roll carts should place garbage bags inside the roll cart, but are permitted to place excess garbage bags neatly at the curb, beside the roll cart.

Recyclable materials - single-stream recycling allows for the commingling of recyclable materials loosely placed in a county-provided recycling roll cart; recyclable materials should not be placed in plastic bags; please visit www.dekalbsanitation.com for a complete listing of acceptable recyclable materials.

Boxes - must be flattened when placed curbside.

Yard trimmings - leaves, pine straw, etc., must be placed in biodegradable bags or a durable plastic or metal container with a 20- to 40-gallon capacity; containers must not exceed 50 lbs. in weight; limbs and brush must be four feet or less in length and neatly bundled; large volumes of limbs and brush may require a special collection; plastic bags containing yard trimmings will not be serviced.

Collection day procedures - Garbage, recycling and yard trimmings containers must be placed curbside before 7 a.m. and removed by 7 p.m. on residents' designated collection day.

Bulky items - the Sanitation Division collects household appliances, furniture and other bulky items free of charge; residents should call (404) 294-2900 to report bulky items placed at the curb.

Special collections - fee required; includes carpet, construction and demolition materials, stumps, improperly prepared yard trimmings, tree parts, trees cut by landscapers, automobile tires (up to four), dead domestic animals, large quantities of unflattened boxes, etc.

Prohibited materials - needles, batteries, dirt, rock, concrete, automobile bodies and parts, paint, oil and hazardous materials; prohibited materials commingled with household garbage; it is the resident's responsibility to properly dispose of prohibited items.
