UNFINISHED BUSINESS

A) November 3, 2020 General/ Special Election Advance Voting Times and Locations

Ms. Hamilton provided the proposed dates and times for the advanced voting period:

- Saturday October 17th and 24th from 9:00 a.m. to 6:00 p.m.
- Sunday October 18th and 25th from 12:00 p.m. to 6:00 p.m.

Motion by Mr. Lewis and seconded by Mr. Tillman to approve the proposed advanced voting locations, dates and times. The Board discussed how the proposed locations correspond to locations recommended to the Board and the equitable distribution of the locations based on where drop boxes are placed. Motion carries 4-1. Ms. Smith voted nay.

B) November 3, 2020 Election Day Polling Locations

Ms. Hamilton reported there are about five locations that she is still waiting to hear from. Ms. Hamilton has back-up locations if a prospective location cannot be secured. Approval of this item is deferred to a later date.

NEW BUSINESS

A) September 29, 2020 Election Certification Meeting

Ms. Hamilton requested that the this meeting be scheduled for October 9th. Motion by Ms. Smith and seconded by Mr. Vu to change the October 8th meeting to October 9th. Motion carries by unanimous vote.

B) County Resources

Ms. Howard provided an update on polling place training for the November 3, 2020 Election. 141 administrative clerks and monitors have been trained to date. Training will conclude on October 28th. An additional 60-65 individuals will be trained and placed on stand-by.

Ms. Hamilton provided updates and ensured that the department is well-staffed and prepared.

C) BRE Meetings & Updates

Ms. Smith recommends holding weekly meetings until the election in November. Motion by Ms. Smith and seconded by Ms. Motter for the Board to establish weekly meetings, for every week moving forward, until the November 3, 2020 General Election. Mr. Vu suggested incorporating updates from other department staff members for future meetings. Motion carries by unanimous vote.

BOARD COMMENTS

Mr. Lewis recommended that instructions be provided to the public via the VRE website to help guide voters with filling-out and completing their registration forms and absentee ballot applications, in order to prevent common mistakes. Ms. Smith echoed this recommendation.

Ms. Motter and Ms. Smith each expressed concern that the department is not cooperating with NVAHI and Mr. Burton.

ADJOURNMENT

Motion by Mr. Lewis and seconded by Mr. Vu to adjourn this meeting. Motion does not carry. Mr. Vu, Ms. Motter and Ms. Smith all vote nay. Mr. Tillman turned the meeting over to Mr. Vu for the remainder of this meeting.

Mr. Tillman left the meeting.

Motion by Ms. Smith and seconded by Ms. Motter to hear comments from the Commissioner. Motion carries by unanimous vote.

Mr. Lewis left the meeting.

COMMISSIONER COMMENTS

Commissioner Lorraine Cochran-Johnson addressed the Board. Ms. Cochran-Johnson commented that to her knowledge, an agenda was not posted which is a violation of the Open Meetings Act. Additionally, Ms. Cochran-Johnson was disappointed that the Board did not vote to extend advanced voting hours.

Public Comment #6

Public comments to DeKalb Board of Elections, 9/25/20 There are many areas of concern. Today I will focus on the absentee ballot process and security of the ballots, Covid19 at Memorial Dr. office, and lack of communication to the public.

Absentee Ballot Process: how will you ensure you will process absentee ballot applications within three days of their ARRIVAL to the elections office; inform people if their application or ballot is reject and how to correct the problem so their vote will count; how to have all ballots processed by 11/2 so on 11/3 you are only processing those ballot left in drop boxes/Memorial office.

Absentee Ballot Security: What is the process for receiving and securing the applications and the ballots. Protocols for picking up ballots from drop boxes with security. Where will you keep and process them? Other counties have secured larger facilities for their absentee ballots. Memorial drive is small with limited room. How will the selected facility be secured/locked with security guards?

Impact of COVID19: Apparently you have closed Memorial Dr office twice now for deep cleaning. What is the plan to continue work if a Covid case occurs among staff on or around election day?

Should the Memorial Dr. Office continue to be an early voting site? Can you redesign it so voters do not go into the main lobby of the offices to early vote but keep early voters separate?

The VRE website and communications are lacking: Today, 9/24/20, I finally see the words "NOV 3" on the website, but much information is lacking. Ballots were mailed before the website acknowledged that there is an election Nov. 3. Communication with voters is a major issue that

should be corrected ASAP. There is no referral on the website to the SOS portal for requesting an absentee ballot. Will the public be able to contact the VRE office with problems and get answers – do you have enough informed staff?

Public Comment #7

Dekalb Board of Registration and Elections,

I am again submitting comments due to my continued concerns about DeKalb's readiness for the November election with its anticipated record turn out and unprecedented use of absentee ballots in the middle of this pandemic. The questions being raised nationally about vote by mail and election integrity demand a level of planning, execution and transparency beyond reproach and unfortunately that is not what appears to be playing out in Dekalb County. My specific concerns include:

1. **Backlog of absentee ballot applications.** I submitted applications for the August, November and December elections via email on June 15th. While I received my August ballot timely, my November and December applications have still not been processed (while my husband's November application sent in the same email was processed on August 17). Ironically, I then received two applications from Dekalb County this week. I have heard similar issues from many other voters and yet the director stated this week in several forums that there is no backlog and applications are processed within 3 days. While I commend you for sending postage paid applications to all registered voters, doing so with less than 40 days until the election contributes to voter confusion, duplicate submissions and challenges with timely processing.

2. **Processing of absentee ballots.** The new emergency rule allowing processing of absentee ballots two weeks ahead of Election Day needs to be fully leveraged to provide for timely reporting of election results. Yet it appears that many critical factors are still not finalized including space, staffing levels, and equipment capabilities. And the engagement of expert consultants from the National Vote At Home Institute has been not been embraced. Detailed plans need to be finalized using national best practices and communicated to the public immediately to regain any confidence in the use of absentee ballots.

3. **Transparency**. Watching the Board meetings and related Commission Ops meetings over the last months, raises concerns about transparency. Basic operational metrics are not provided to Board members, Commissioners and the public. Information has not been provided to the consultants impacting their ability to support readiness for this critical election. This is unacceptable, transparency for this public function is basic to our democracy. In addition, like the State Election Board, this Board should take live public comments, especially since the

submitted comments are not even acknowledged. This Board is ultimately accountable to the residents of Dekalb County and should value this public input.

4. **Communication**. With only 39 days to the election, the Communications consultant plan needs to be implemented immediately. Communication on drop box locations, early voting locations/hours and polling place changes needs to be communicated to the public as soon as possible. The web site also needs an overhaul to provide useful information to the public in a user friendly format.

I am very concerned that without these issues being addressed immediately, we will again see break downs on Election Day and the timely reporting of election results, potentially calling into question the very integrity of this important election.

Public Comment #12

Dear Board Members:

We should all be concerned about the allocation of DeKalb's check-in equipment, which I have not heard discussed in your meetings.

The long lines of June 9th will be repeated at large polling places unless they get more equipment and get more poll workers trained to use them. On June 9th, all polling places were given two Poll Pads, with just a couple of exceptions. Testimony at the Governmental Affairs Committee, as well as reports from voting activists and news outlets, have consistently identified Election Day check-in procedures as the key bottleneck.

The variation in active voters per polling place is dramatic. Over 5000 per polling place were assigned to Miller Grove Middle School, Meadowview/Clifton and Rock Chapel Road, and all had to stay open late. Contrast this with Livsey Elementary, Kelly Chapel, and Warren Tech, with fewer than a third that many active voters. Turnout was much smaller at these locations and they closed on time — but all got the same number of Poll Pads: two.

I talked to poll workers doing check in who told me they didn't want to take bathroom breaks on June 9th because there was always a long line. If small polling places need two machines (they break down a lot, so this may be prudent), then by all means buy more. If they are not available, supplement with the kind of equipment the county already uses during Early Voting. And make sure printed paper poll books are up to date and that poll workers know how to use them.

Some of the lines on June 9th were caused by equipment failures, some were caused by large turnout – but somebody needs to look at numbers and allocate resources accordingly. It is the job of this board to make sure that happens.

I am Representative Viola Davis and I serve Georgia House District 87. I am writing this public comment to voice my concerns about the absentee ballot process. I have a long history of fighting for transparency, ethics, and accountability. I commend the employees at the Board of Registration and Election for their hard work, especially during the COVID-19 pandemic. They are essential workers that help with securing the vote. With the Coronavirus pandemic, the absentee ballot process has proven to be an especially important process for voting in America, especially for people who want to protect themselves from COVID-19. In June, I mailed my absentee ballot on the same day as my parents who live in Gwinnett. My parents received notice that their ballots were received quickly by checking online. I tracked my ballot online for over two weeks. However, I waited over two weeks before I noticed that my ballot was received. How can we mail our ballots on the same day and I had to wait an additional two weeks for a notice that my ballot was received?

I received multiple complaints from constituents, family members, and friends about the absentee ballot process. I made several calls to the Secretary of State office and our local Board of Elections. We need to hire more people to ensure the process moves smoothly and without confusion and/or complaints. We need a quick turnaround time.

I hope and pray that we work together to improve the process to ensure everyone can vote and know that their vote was counted.

Public Comment #14

To the Dekalb Board of Registration and Elections (BRE):

Please address the following comments and concerns <u>during</u> your meeting on September 25, 2020:

- 1. What is the status of your preparation for mailing out requested absentee ballots, processing returned absentee ballots, and ensuring that absentee ballots are quickly processed so that they can be immediately counted at the time the polls close on November 3, 2020? Who is in charge of the entire absentee ballot process from end to end? Will you institute ballot review panels as soon as you see that a voter has used a check mark or "X" on an absentee ballot instead of filling in an oval to vote for a candidate? Do you have a designated team to immediately inform voters when their absentee ballot is rejected? Please clarify what "processing" absentee ballots prior to the close of the polls on Election day entails. Does it mean checking the voter's oath signature against your registration records, opening the outer ballot envelope, opening the inner ballot envelope, and scanning the ballot using a scanner that will scan but not tally the ballot? What are you doing to ensure that the place or places where absentee ballots are being processed, will not have to shut down due to someone showing signs of, or testing positive for, Covid-19? Please provide full detail to the public about what you are doing to expeditiously, safely, and securely manage the absentee ballot process. Will you have multiple shifts working around the clock, if necessary? Did you in fact order AND receive additional scanners to scan absentee ballots as you indicated you would do some weeks ago?
- 2. What is your communications plan, who is your point person, and how have they been trained? Have you allowed (and trained) the staff from other County departments, as offered by the DeKalb County Commissioners? Please share the written plan, or a substantial written summary of the plan, with members of the press and the public. Without that, our concerns that your preparations are woefully lacking continue, as the June primary remains a chaotic, bitter, and frightening debacle in our minds.
- 3. What have you done to ensure rapid processing of voters on Election Day? Have you purchased additional poll books? Have you hired and trained technicians to repair any technological problems at every polling site? If you have not done this, when will it be completed? Will you have an additional line for those who decide not to vote absentee, but wish to come to vote in

person? As it appears their needs take longer than in-person voters who did not request an absentee ballot, how will you process these voters in an expeditious manner? Separate, dedicated lines? Post a notice of the closest drop box locations to that precinct's polling place? What are you doing to ensure that if lines get too long, that voters may be checked in quickly and given an Emergency (not provisional) ballot? Please give concrete examples that will assure the public that you have thought about, and prepared for, the obvious snags in the process and have devised ways to eliminate such problems.

4. How is the BRE holding management of the Voter Registration and Elections Department (VRE) accountable? It has been clear from past meetings in 2020 that the VRE has failed to demonstrate that it is fully prepared, so we are looking to the BRE to aid with this concern.

Chairman Tillman, Vice-Chairman Vu, and Board Members Lewis, Smith, and Motter:

Thank you for the opportunity to share my thoughts. I am Susannah Scott, the president of the League of Women Voters of Georgia, and a life-long resident of DeKalb County. I am committed to the League's mission of empowering voters and defending democracy.

I would like to first note that this Board habitually fails to post meeting agendas and minutes in a timely fashion, in contravention of the Open Meetings Actn (§50-14-1). The agenda for today's meeting has not yet been posted, nor have minutes since June 29, 2020 Special Called Meeting. Given the importance of the upcoming November 3 election, it is imperative that this information be made available to the citizens of DeKalb.

Additionally, as this Board prepares for the November 3rd election, I ask that you pay particular attention to the following:

- Ensure there is adequate PPE for all poll workers for the full early voting period and on Election Day.
- Ensure that absentee ballot drop boxes are located throughout the county, especially in more remote areas where there is less access to public transportation.
- Finalize the hire of the Communications Director.
- Direct the Communications Director to ensure that the election's website is easy to read, coherent, and provides up-to-date information for voters including emergency polling location changes, including the location of absentee ballot drop boxes.
- Direct the Communications Director to create an FAQ page to address common questions, including how to check their registration status, the status of their absentee ballot requests, what provisional ballots are and how to ensure they are counted, and the time frames for counting absentee ballots.
- Ensure each polling location has a sufficient number of paper/provisional ballots.
- Ensure all poll workers have a clear understanding of both how to handle voters who requested absentee ballots but have opted to vote in person (whether because they never received their

ballot, or decided they'd prefer to vote in person), as well as when it is appropriate to have voters vote on a provisional ballot.
