DeKalb Voter Registration and Elections to Hold Special Called Meeting on June 9

[Decatur, Ga.] – DeKalb Board of Registration and Elections (DeKalb BRE) will hold a Special Called Meeting on Monday, June 9, at 10 a.m. to consider two temporary polling place changes related to the upcoming special election for the Georgia Public Service Commission (PSC) on June 17. This meeting will be conducted in person at 4380 Memorial Drive, Suite 300, Decatur, Georgia 30032 and is open to the public. The DeKalb BRE will consider the following changes:

- The polling place for the combined precincts of Henderson Mill (HC) and Midvale Road (MW) would relocate from Henderson Mill Elementary School to Warren Technical School located at 3075 Alton Road, Atlanta, GA 30341.
- The Toney Elem (TC) polling place would relocate from Toney Elementary School to Kelley Lake Elementary School located at 2590 Kelly Lake Road, Decatur, GA 30032.

“Ongoing construction at previously designated Election Day polling places requires DeKalb BRE to consider a pivot to nearby locations to ensure a safe and convenient voting experience,” said DeKalb Voter Registration and Elections Executive Director Keisha Smith. “If approved, my office will mail notices to all impacted voters, place signage at the original polling places and share this information across our various communications channels to minimize voter confusion and inconveniences during this election. These changes, if adopted, are temporary and voters will return to the designated polling place for future elections.”

Public comments may be made in person or submitted by sending an email of one printed page or less at a minimum font of 12 to electionspubliccmnt@dekalbcountyga.gov which must be received between 35 and 5 minutes before the scheduled start of the meeting. The body of your email must include your first and last name. By submitting an email for public comment, you agree to have your name and the email broadcast on the UStream and entered into the record and minutes.

The DeKalb Board of Registration and Elections reserves the right, at the DeKalb Board of Registration and Elections’ sole discretion, to (1) add your email to the record/minutes without reading any of it into the broadcast or (2) read all or a portion of your email into the record/minutes. All public comments will be limited to 2 minutes. Abusive, profane, or derogatory

language, holding up signs, clapping, yelling, standing, or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.
