Goals of the Trail Study


Goals of Study

- Work with the community to propose a trail centered around Mercer University
- Reconnect neighborhoods separated by interstates
- Enable non-car travel to key destinations and to regional trail network


Desired Outcomes

- Provide neighbors access to the unique ecological areas of Mercer's campus.
- Enhance physical, mental, and social health through outdoor recreation
- Empower people with mobility challenges to enjoy the benefits of trails and natural areas
- Educate residents, workers, and students of all ages about their environment
- Identify and address the privacy and security of residents who live near trails



- Get around without driving


"We love the idea of having trails connected to our neighborhood. Having safe and accessible trails with a natural setting is a huge perk for everyone. Thank you for considering our area."

"Do not want this - does not need to be in our neighborhood - more people - no!"


Original Trail Opportunities in/near Study Area



Responses to Concerns

Following the third round of public engagement DeKalb RPCA have determined the following changes in the trail.


- 1. Cravey Trail Spur Removed
- 2. Henderson Mill Creek Trail east of Hollinswood Drive and Rangewood Trail Spur Removed
- 3. A Flowers Road and Henderson Mill Road sidepath were added to make the trail connection from PCG to Henderson Middle School.









Trail Opportunity Segments







Merver University trail opportunity Segment P (number keys relate to photos on previous page)



Merver University trail opportunity Segment M (number keys relate to photos on previous pages)




Merver University trail opportunity Segment H (number keys relate to photos on previous pages)




Merver University trail opportunity Segment E (number keys relate to photos on previous page)
