
## Intrenchment Creek Park




## Intrenchment Creek Park (connectivity)

## Survey Results from Poll and Mailing

  - ▶ 39 respondents provided input

DeKalb County Recreation, Parks, and Cultural Affairs is excited to announce that the DeKalb County BOC approved the proposed land exchange at Intrenchment Creek Park. The proposed exchange includes three parcels totaling 55 acres along Bouldercrest Road.

Wood is tasked with creating a master plan for the entire Intrenchment Creek Park. The plan will include renderings to assist community members to visualize the potential this space offers . Throughout the planning process, there will be public meetings in which the community can provide comments to be incorporated into the plan, so that the park master plan reflects the desires of the community that it will serve.

Together with DeKalb County Recreation, Parks, and Cultural Affairs, we expect the park to be predominantly a passive park including trails, landscaping, an outdoor classroom, pavilions, seating, and other amenities that will provide community value.





## Mailing Results - Additional Comments


- Emphasize greenspace/trails and open space
