Filing a new registration application and payment of applicable fees and taxes will be required of the new owner of the business. Failure to submit a new registration application and to pay any applicable fees will be grounds for revocation. Any attempt to transfer a business occupation tax certificate may result to being penalized as provided in section 1-10 of this code. Alcohol License is not transferable; no license for the sale of alcoholic beverages shall be transferable, as stated by Code Section 4-53.






