Congratulations! You are applying for the 2020 Business and Alcohol License renewal. This letter serves as the official notification beginning October 1, 2019. To keep you informed, this is the third notification letter updating our customers of the **NEW RENEWAL PROCESS** and **IMPORTANT REMINDERS.** This letter includes information on how to obtain PDF fillable forms, online account access, and payment method.

NEW RENEWAL FORM and PROCESS

• 2020 ALCOHOL AND BUSINESS OCCUPATION TAX RENEWAL FORM

To facilitate the change pursuant to code section 15-32 (a) "Occupation taxes on all businesses who hold an alcohol license shall be required to be renewed, in conjunction with the alcohol license, no later than December 31 of each year." We have consolidated the **Alcohol License and Business Occupation Tax Renewal Forms**. Enclosed are the Alcohol License renewal form (Page 1 of 2), and the Business Occupation renewal form (Page 2 of 2). See attached 2020 Renewal Filing Requirements and Instructions on how to complete and submit the form(s).

• ONLINE ACCOUNT ACCESS AND PAYMENT

Authorized business representatives are now able to go online through The DeKalb County Dynamic Portal to access their account. This is the new DeKalb County e-Permitting website. You must first set up (register) an account in order to view, or pay fees online. (See enclosed instructions on how to register) When the renewal application is processed by the business license division, the authorized business representative will have access to pay taxes and fees due.
