# In DeKalb County, we respect your right to protest — and we want to help you do it safely and lawfully.



#### Do...

- ✓ Seek approval for use of any public space from lawful owner.
- ✓ Notify local law enforcement of protest date, time, and route.
- ✓ Have a readily available point of contact on file with law enforcement.
- ✓ Keep to public spaces and sidewalks unless permitted otherwise.
- ✓ Get a permit if you plan to march in the street.
- Cooperate with law enforcement officers.
- ✓ Follow commands from law enforcement during protest.
- ✓ Follow dispersal notices or traffic redirection during protest.
- ✓ All participants, including media, must follow lawful orders.
- ✓ Stay peaceful and nonviolent.

#### Don't...

- × Block roads or entrances without a permit.
- × March in the street if you have not obtained a permit.
- X Bring weapons or objects that could be seen as weapons.
- X Engage with agitators or incite violence.
- Disregard police instructions or safety guidelines.
- X Cover face with scarves, bandanas, or fabric coverings (not including medical masks).
- X March down highway ramps.

# Your Right to Protest: What the Law Says

- The **First Amendment** of the U.S. Constitution protects your right to peacefully assemble and express your views.
- In Georgia, your right to protest is upheld—but may be subject to reasonable time, place, and manner restrictions.
- Local ordinances may require permits for marches or use of amplified sound.



# Permits & Planning: When and How to Get a Permit



- A **permit is required** for marches that block traffic, large public gatherings, and events using amplified sound.
- Apply through the **DeKalb County Police Department**, depending on the protest location.
- Provide details such as date, time, route, number of attendees, and a point of contact.
- Apply at least 10 business days in advance when possible.

# The Role of Law Enforcement in Peaceful Protest



#### Law enforcement is present to:

- Ensure the safety of protestors and bystanders.
- Manage traffic and public space access.
- Respond to emergencies or unlawful activity.

#### Note:

Participants and media must follow lawful orders, including dispersal notices or traffic redirection.

#### **Note for Media:**

Members of the press are welcome, but must:


- Avoid restricted areas or interfering with police operations.
- Follow any orders issued by law enforcement.
- Comply with law enforcement and public safety instructions.

## How to Plan a Peaceful Protest: A Step-by-Step Checklist



- Clarify your purpose.
- Assemble an organizing team (e.g., point of contact, logistics, safety, etc.).
- Choose a location, date, and time.
- Apply for necessary permits.
- ✓ Plan your route and notify all appropriate authorities.
- Promote your event responsibly.
- Prepare a safety plan.
- Do not engage in combative behavior.
- Have a point of contact on file with law enforcement.
- Be organized in your approach to maximize effectiveness.

### Frequently Asked Questions



#### Q: Do I need a permit to protest in a park?

A: Yes, regardless of the size of the crowd.

#### Q: What if someone at my protest becomes violent?

A: Encourage participants to remain calm and peaceful. Notify law enforcement immediately.

#### Q: Can I record police activity?

A: Yes, if you do not interfere with their ability to perform their duties.

#### Q: What if I get arrested?

A: Stay calm. Do not resist. Ask for legal representation and note the arresting officer's name and badge number.

#### Q: Can I park at retail shopping centers, schools, or churches while I protest?

A: No, you must always seek permission to use private property if you are not there to conduct business at the location.
