NOTICE OF PROPOSED POLLING PLACE CHANGES FOR THE MAY 19, 2026 GENERAL PRIMARY ELECTION AND RUNOFF

The DeKalb County Board of Registration and Elections (the BRE) hereby gives notice to the voters of DeKalb County that it is considering the following polling place changes for the May 19, 2026, General Primary Election, in accordance with O.C.G.A. 21-2-265(a). These changes will become effective following the second publication of this notice unless the BRE receives public comment in opposition to such changes, in which case the BRE will hold a special called meeting to consider public comments received and further action on the proposed changes.

The Board proposes the following temporary relocations, which will return to their permanent locations for the November 3, 2026, General Election:

1. Cross Keys (CO) and Woodward (WJ) precincts from Cross Keys High School to Woodward Elementary School, 3034 Curtis Dr NE, Atlanta, GA 30319.
2. Ashford Park Elem (AB) precinct from Ashford Park Elementary School to John Lewis Elementary School, 2630 Skyland Dr NE, Atlanta, GA 30319.
3. Stone Mountain Elem (SD), Stone Mtn Champion (SP), and Stone Mtn (SQ) precincts from Champion Theme Middle School to St. Michael and All Angels Church, 6780 James B. Rivers Memorial Dr, Stone Mountain, GA 30083.
4. Wynbrooke Elem (WN) precinct from Wynbrooke Elementary School to Stephenson High School, 701 Stephenson Rd, Stone Mountain, GA 30087.
5. Idlewood Elem (IA) precinct from Idlewood Elementary School to Stone Mountain Middle School, 4301 Sarr Pkwy, Stone Mountain, GA 30083.
6. Candler-Murphey Candler Elem (CF) precinct from Murphey Candler Elementary School to Arabia Mountain High School, 6610 Browns Mill Rd, Stonecrest, GA 30038.
7. Sagamore Hills Elem (SA) precinct from Sagamore Hills Elementary School to Outlet Community Church, 3039 Briarcliff Rd NE, Atlanta, GA 30329.
8. Kingsley Elem (KB) precinct from Kingsley Elementary School to Kingswood United Methodist Church, 4896 N Peachtree Rd, Dunwoody, GA 30338.
