### **DeKalb Voter Registration and Elections Announces Two Temporary Election Day Polling Location Changes for June 17**

*DeKalb Board of Registration and Elections Approves Emergency Polling Place Relocations Due to Ongoing DeKalb County School Construction*

**[Decatur, Ga.]** – DeKalb Voter Registration and Elections (DeKalb VRE) is notifying approximately 7,000 voters about two temporary polling location changes related to the upcoming special election for the Georgia Public Service Commission (PSC) on June 17. Following a June 9 Special Called Meeting, the DeKalb Board of Registrations and Elections unanimously approved two temporary Election Day changes:

- The combined precincts of Henderson Mill (HC) and Midvale Road (MW) will relocate from Henderson Mill Elementary School to Warren Technical School located at 3075 Alton Road, Atlanta, GA 30341.
- The Toney Elementary (TC) precinct will relocate from Toney Elementary School to Kelley Lake Elementary School located at 2590 Kelly Lake Road, Decatur, GA 30032.

“Ongoing construction at previously designated Election Day polling locations requires DeKalb VRE to pivot to nearby locations to ensure a safe and convenient voting experience,” said DeKalb VRE Executive Director Keisha Smith. “We are mailing notices to the approximately 7,000 impacted voters, placing signage at the original precincts and sharing this information across our various communication channels to minimize voter confusion and inconveniences during this election. Please note that these changes are temporary for the June 17 election and any subsequent July 15 runoff.”

Early voting continues through June 13, Monday–Friday, 7 a.m. to 7 p.m. During Early Voting, DeKalb voters can take advantage of 10 convenient early voting locations, with six sites offering

secure drop boxes for hand-delivery of absentee ballots. Click [here](#) for a list of advance voting and drop box locations.

## **PAGE TWO: PSC ELECTION DAY PRECINCT CHANGES**

During the June 17 Special Primary Election, all voters will see District 2 and District 3 contests for the PSC on their ballots, regardless of where they live in DeKalb County. Although candidates qualify by district, the PSC is a statewide office. Voters do not vote by district, but by selecting their party preference, as this is a partisan primary election.
