Health Benefits Package

Rader: Has this been fairly effective in reducing claims experience for those that are in the HSA?

Can you do a deeper dive on the impact on service use, when segregate out similar cohorts in the HSA?

Is the HSA cheaper for us because of the sorting of lower risk individuals into it, or is it because it actually affects behavior?

Davis-Johnson: What percentage has enrollment in our HMO plan changed over the years?

Rader: I'd be interested in looking at the what the actives are contributing in excess to the HSA. I'd like to know if they're doubling down on their own contribution of the tax deductibility of it and putting their savings into the HSA.

Rader: Given that our claims experience has been fairly stable, is the stop-loss also fairly stable?

How much does an on-site clinic help to deal with those, would you expect these large dollar claims to go down once something like that is fully implemented?

Rader motioned to recommend increases for actives and early retirees. Jester clarified, a 5 percent (active) and a 17.5 percent (early retirees). Jester seconded the motion. Recommended for approval 3-0-0.
