Accept a COVID-19 Public Assistance Grant from FEMA as a pass
through via GEMA for expanded vaccine operations in the county.
DeKalb has been obligated up to \$9,587,753.82 for the significant
expansion of Emergency Protective Measures.

- -COO Williams: this is an item that was presented to the Board previously. This will be used in 2 tranches, for standing up additional sites, 10 buses, and pop-up sites. The Board can anticipate a contract with the DPH; this is a strong first step in our vaccination strategy.
- -Question MDJ: regarding incentives to our residents, is this taken into consideration of this strategy? COO Williams: incentives may be one of the many necessary ways to help; unfortunately this grant doesn't allow these funds for incentives. Which leads us to consider whether there are other resources to retrieve funds for incentives. We've had conversations on incentives during the application process; the indication we received was that this was not eligible for incentives. I will confirm whether there is a specific statement provided regarding the allocation of funds for incentives within the grant.
- -MDJ: we want to encourage people to be vaccinated, and create the herd immunity. We can explore means other than money -COO Williams: incentives are a means to reach herd immunity through the furtherance of vaccines. These incentives may come in many different forms
- -Question LJ: The reason why folks aren't getting the shot is one of the main questions. I hope we can use this for more than vaccinations; we can utilize funds for evictions. Let's have a holistic strategic, case managers for mortgage/rent relief, jobs, etc. We can have more services offered at these sites that can help people via ancillary services in these areas. Even food box distributions can be used to capture these groups.
- -Question TT: I would like to emphasize commissioner Johnson's comments; we should identify on-the-ground, in the community knowledge and experience. A similar approach that was used during the Census; the engagement we need is direct; having pop ups and more access is a key part to it; but this is about persuasion, similar to getting people to vote. We need to knock on doors. I would suggest that a small portion of these funds could be used for an Activation Team to knock on doors and notify residents of these services.
- COO Williams: that is one of the many things we are looking to do; this would involve working with our community partners through our Health Department. A build it and they will come model works for the first 35%. Now we have to find ways to go to where people are, and ensure access is there for those that are transportation-dependent.
- -LCJ: each time we discuss this there is a resounding consensus. I would like to see the plan that accompanies the dollars for this FEMA grant. We are awaiting to see what the administration has developed; getting these last individuals who have not wanted the vaccine will need a very focused approach around education and marketing. From there we can make logical recommendations. This requires a serious conversation amongst our younger generations. I look forward to hearing a plan for the administration.
- COO Williams: What we will show is what they are funding, which includes the staffing of these buses, mobile sites, education outreach programs that add up to this dollar amount. We will get you that in the next day or so.

 MDJ: My biggest concern is how can we attract young people

-Question MDJ: if there's a privately owned vehicle that is towed, and the cost is paid to the company, why does the County only receive a percentage?

Greg Ivanov: there are 2 portions of this contract; 1 bills the rates to the individual in which the County receives a portion; the other portion involves a cost-neutral aspect of the contract.
