II. STATUS UPDATE

Indigent Grave Markers

-presentation from Director Pat Bailey

-Ouestion MDJ: what would be the cremation vs. burials cost.

P Bailey: the cremations are significantly less than burials; the indigent costs would not exceed \$2150. Burials run you from \$1900-\$5000

-Question MDJ: are you still reviewing grave markers for already-existing graves?

P Bailey: yes we are

-Question JR: are currently placing markers on new burials?

P Bailey: with the allocation put forward by the BOC would allow us to move forward in that direction. My expectation is to move forward with going back with those we can identify to put some sort of monument there; for those that we can't we would put a memorial wall in a 'praying garden' designated area

-JR: please include a feature in that praying garden you have discussed, so that those who are cremated can have their remains deposited there is so desired by the families.

-Question JR: How many unclaimed indigent burials do we have, in which the family is not available to provide information on cremation and other services?

P Bailey: that will take a little more research with state records

-Question JR: Do we have an estimate of the annual cost for maintenance of the burial grounds? Would this be something that Parks would handle in their mowing contract?

C Ellis: what comes out of the study that is being done will determine the cost price for maintenance

-Question MDJ: properties are being maintained once a month? Who is maintaining?

P Bailey: the original location is behind Roads and Drainage facility and they maintain on a schedule. The other is near Seminole, and I will have to get their schedule to understand their maintenance schedule.

-Question MDJ: have we began a process to identify who is buried where for indigents?

P Bailey: yes, we have some records going as far back as 2010; before that will be more research due to when we migrated to an actual database. Those records may not be digitized. Death records may still be available to us back to 1950, but the method in which they're kept could be different

-Z Williams: we have included this in the budget; a formal endorsement of this would be great because it would be consistent with what was proposed in early Spring

-JR: Motion to endorse this expenditure as consistent with the FY21 revised midyear budget amendment.
