II. STATUS UPDATE

Brannon Hill Condominiums

- -information provided by Assistant Chief Padrick
- -Question TT: there is still a lookout for this individual?
- -G Padrick: yes sir and we are working with the Sheriff's office Fugitive Apprehension Unit, and the homicide assault unit number 770-724-7850 if anyone has information related to the suspect
- -Question SB: regarding the incident, it started at Brannon Hill, they took it somewhere else, and they came back?
- G Padrick: It is dispute related of a dispute that occurred a couple of days earlier; the party left and returned later
- -Z Williams: Director Mitchell will come on to discuss historic and present activities at Brannon Hill. Director Hardy will follow up with the ongoing code enforcement activities, and Attorney Ernstes will discuss the litigation in court. I will discuss ARP funds that can be allocated to address this and also announce an upcoming food giveaway at Brannon Hills
- -information provided by Director Mitchell
- -Ouestion TT: has the law department provided information related to eminent domain? Has the County utilized this?
- A Mitchell: for right of ways but not for general purposes
- -information provided by COO Williams on ARP funds related to affordable housing
- -information provided by Director Hardy on the code enforcement aspects
- -Question TT: is the condominium association still responsible for code violations?
- T Hardy: That's correct for common areas; as it relates to specific units the owners of the units are responsible
- -Question TT: are there other buildings under investigation?
- T Hardy: those are the only 2 now that are being actively investigated? If other buildings do meet the criteria we'll process those as well -information from County Attorney Ernstes on outline the statutory IN REM process, of this specific case, and discussion of the eminent domain issue
- -Question TT: what happens after a building has been condemned and there is a concrete pad; who owns that pad? V Ernstes: information provided by Attorney Ernstes
- -TT: a lot of the remediation has been around the blight task force; I understand there are procedural issues to go through. If we continue on with just the blight focus, clearing out the buildings one by one, we are not addressing the vacant slabs. What can we do beyond what is already happening, while we work our way through an ultimate solution of condemning the old buildings? I williams: ultimately I think where the conversation goes is what does affordable housing look like in DeKalb County? There will be units that leave a lot to be desired. I don't know how we have that conversation, but there are number of other multi-family housing complexes around DeKalb that have no other choice other than extended stays. We will try to make it as safe and clean as possible, but the conversation is broader than this
- -TT: it is broader, but I want to address what is happening at Brannon Hills. A blight strategy is not enough, because what comes after that is replacing those properties on site. Brannon Hill is the problem and is begging for more attention. In the Memorial Drive revitalization study, not a word mentioned Brannon Hills; Memorial Drive revitalization doesn't happen as long as Brannon Hill continues to be the center of crime and other issues happening. What is the long term approach to turning this around?
- -Z Williams: I believe we're on the same page; our attempts and success at addressing blight has improved the condition but has not turned it around in a way that we would like. We need to revisit what are the policy decisions that need to be made, whether it be housing assistance, eminent domain, etc.
- -TT: we should have some updates from the blight task force
- -Z Williams: that would help with a lot of this in sharing the information of what is being done and would help to develop policies.
- -MDJ: you are focusing on Brannon Hills, which is one of the issues; I believe it's a much larger discussion rather than the complex itself
- -TT: this is a walk and chew gum opportunity to address the multifaceted issues. This is also a question of equity, when the community has asked for help for years, and the government doesn't take action after the cameras are gone
- -LCJ: Attorney Ernstes I will speak with you offline on the County recouping monies invested in Brannon Hill related to repairs and actions related to public safety
- -TT: I had 6 and a half years as Mayor of Clarkston; we have got to do more; I am now a Commissioner for this area and we have a responsibility to keep this a top priority. COO Williams could you mention what is happening this Saturday?

- -TT: what are we doing to clean up the public health issue that is in the parking lot? I have a request from an organization to waive the landfill tipping fees so they can clean it up
- -Z Williams: I will see if I have the authority to waive the tipping fees; but we will take care of it commissioner
