FY22 Budget Presentation

- -high points of the budget provided by COO Williams
- -presentation provided by Central Staff
- -Commissioner Terry requests Central Staff provide departmental changes, separate from pension allocation, that would provide a more comprehensive look at notable departmental changes in the proposed FY22 budget
- -Question LCJ: have we heard from departments that feel their funding is not adequate?
- TJ Sigler: I've discussed with departments and have taken notes on those requests, but no decision has been made on that at this point
- -Question TT: regarding the sustainability portion of our Planning and Sustainability department, we're not doing too much related to climate-action. I'm not seeing the commitment in DeKalb to make this happen. I would suggest that with more funding and coordinated effort, we can get back to silver and gold status in our Green Communities submission. I would like to see more climate conscious work in this budget.
- -Z Williams: what you articulated would be a perfect example would put forward to state policy statements to be funded in terms of studies, staffing, etc. The timing is now -presentation by Director Sigler

2022-1030 Commission District(s): All Commission District

A resolution (1) authorizing the issuance and sale by the County of its Tax Anticipation Notes (Federally Taxable) due December 15, 2022 in the aggregate principal amount not to exceed \$140,000,000 (TAN) for the purposes of obtaining a temporary loan to pay current expenses during the 2022 calendar year -- not to exceed \$70,000,000 of which will be loaned to the County's Watershed Department as a bridge until the County receives proceeds from its new money water and sewerage revenue bonds expected to be issued later in 2022 and (2) ratifying and approving the appointment of Piper Sandler & Co. to serve as placement agent to the County in connection with the TAN.
