⁻Question LCJ: it looks as though we're spending \$156,000 a month in facilities and preventive maintenance services. This amount is a lot of money. What preventative maintenance services are taking place monthly?

-Question MDJ: is Central Staff on the committee to select the financial advisor?

Dr. Obeng: We will be having conversations with the Administration to determine the necessary parties to be included -MDJ: I don't think that would be appropriate, because I don't think the information they would be gathering would be independent; perhaps Central Staff could provide in writing as to how they perceive their role in this -response provided by Dr. Obeng

-JR: we will have this on our agenda again at the next meeting after fleshing out these details

-JR: at a previous presentation of financial statements, the committee asked for identification of financial anomalies from the financial statements be presented in conjunction with the finance director to inform the committee on those anomalies that would be more of a focus area. Have you begun that process?

Dr. Obeng: that's part of what's on our agenda to have with the Finance Director to discuss this week or next week hopefully for our topics of discussion

-JR: this is on the BOC agenda to come back in 30 days, so we will keep this on the agenda to be heard at our next FAB meeting

IV. DISCUSSION

Midyear Budget Amendments

Public Defender

-information provided by Public Defender Claudia Saari

-Question LJ: what is the increase asked?

C Saari: it depends upon where attorneys are in the particular pay classification range. The pay classification system DeKalb has does not match Fulton - that is the current issue we are working through. We compete with the Fulton County office for well qualified attorneys.

-Question LJ: can you send us what the last salary amounts were in DeKalb? I'd like to see a comparison. Regarding ARP funds, we invested some because there was a backlog. Did those attorneys leave?

-C Saari: they are now permanent positions; I can tell you it's difficult to recruit attorneys with salaries at the ARPA levels; the market is hard and we may have to readjust and pivot regarding extra help with backlog and the courts

-Question LJ: will new attorneys coming in move into those positions with established salaries?

C Saari: I am trying to bring in more experienced attorneys

-Question LCJ: we don't have a specific ask?

C Saari: my ask in the midyear budget was additional \$775,000. But I learned today that I might have additional salary savings, so that number may go down based on the updated numbers.

-Question TT: it sounds like we'll get a more detailed proposal once we get the salary savings. Other than salary is there anything else you're hearing from attorneys or other recruits that we should be doing?

-response provided by Public Defender Saari

-Question TT: is there additional court times in the evenings - is there a strategic plan for clearing the backlog quicker than what it would take during the normal course?

-response provided by Public Defender Saari

-Question TT: regarding the court backlog, is there a paradigm that exists for retired lawyers, judges, those with legal experience - can we ask our community and those that have the experience to do the job, that we could be asking our own residents to help?

C Saari: there's always pro bono services. Most judges staffing those particular divisions are senior judges

-Question TT: is there a situation where there's a case that can't be heard because there's not enough hours?

C Saari: we can only try 1 case at a time, so yes the more lawyers you have the more you can do. That's why we will be trying to utilize more ARPA funds to aid in this effort

-Question TT: should we be considering additional grant funds to organizations that seek to get those volunteers to help? If we support them in addition to what you're asking that would create a net benefit?

C Saari: the challenge with those organizations is they don't do criminal defense work - they focus more on civil work -MDJ: I'd like to tip my hat off to the Public Defender's office. They are very much underfunded when you compare them with district attorney offices. I'm in support of their request - if we can get the money, I'm in favor of getting it

-TT: I totally agree; I also think we should have the same context when we talk about the eviction court

-information provided by COO Williams

-JR: Mr. Williams how will you present those budget amendments to committees of jurisdiction? -response provided by COO Williams

-Z Williams: mid-August seeking the adoption of the budget, and simultaneously seeking a proposal for the ARP budget. I see those 2 activities moving in tandem over the next 30 days

-JR: I would also encourage members of committees to bring forward proposals from Commissioners as well as the constitutional offices

-LJ: please keep us posted on the opioid settlement Mr. Williams
