-TT: you are right; this tends to be more of a rural issue; these unmined coal ponds are usually nearby the coal plants; but there are some communities that may want to take coal ash out of their landfills. Over the years we have the byproducts of fossil fuel decay with other decaying materials that percolates the soil and enters the water system. Juliet, GA outside of Macon is an example of how this impacted nearby neighbors. The Public Service Commission is the other body that we can lobby to address this issue, because they are also dealing with how GA Power regulates coal ash and disposal. I've been talking with Dentons regarding an integrated resource plan, and this is an opportunity to address this issue via lobbying.

- -Question TT: Is it possible that TLAC in the short term can assist with some of those cost centers?

MDJ: that's a good question. A lot of these evictions now will be because of the pandemic. I would like to hear COO's answer Z Williams: so the question is - is funding the removal of household goods and debris an eligible expense through the ERA2 funding. I need to get a legal opinion of that.

T Hutchinson: would this be more so public safety and resident health; maybe that could be an angle?

Z Williams: let us take up the issue and then see what is the most appropriate funding source; it may not fit best under ERA but may fit within other sources; but if you have a public issue, that allows us much more flexibility

TT: I wonder within this process more streamlining and public navigating that we can prevent some of the on-the-street dumping that happens when the Marshall is carrying out duties

Z Williams: the Marshall does their best to give advanced notice; in many cases the debris that is left the tenants may not feel that the objects are worth keeping with them during an eviction; let us work through this

MDJ: that what this does is put the costs on the owner agent filing the eviction rather than the tenant

LCJ: regarding this issue, I get calls on this and it is a chronic issue. I understand the need for legislation, but is this not something that we as the legislative branch can institute and require fees? In many cases when people are moving people find it easier to leave items on the curb rather than be responsible for proper disposal; it's cheaper to keep it on the side of the road, and this creates blight within communities. I don't think this is something that we should have to hold or wait on; I believe we can act on this as the governing body; this is also a way to increase revenue for the department. Ultimately the homeowner is always the responsible person

MDJ: I think we're talking about 2 different things; this talks about eviction and not only people leaving things on the curb; this legislation only focuses on evictions and transporting debris of items left during an eviction. County Attorney Ernstes could you talk about the area of evictions on this?

LCJ: I'm fully aware that when people vacate and fail to dispose, when the county intervenes are we not sending out notifications or placing some sort of lien for these items?

V Ernstes: Commissioner I'll deal with the legislation and Director Hutchinson can address those who dispose of things at the curb. When we are evicting people from their home/apartment, we looked for a way for the County to do this unilaterally without going to the legislature to set a fee. Because we are dealing with a court issue, those fees are set by legislation rather than by control and power by a local authority; this is a court action and that is why we drafted this legislation with respect to having a fee imposed in the context of an eviction. With respect to somebody just putting out their mattress on the side of the road and leaving it I'll defer to director Hutchinson

T Hutchinson: the Sanitation division does not have authority to put liens on properties; so there is no letter or lien that we send out to residents. However residents are directed to go to the bulky portal to enter that process. The evictions come from the Marshall's office; there are 2 different items we are talking about.

TT: some of this may overlap with PWI and the FAB committees

Z Williams: and PECS for code enforcement as well

TT: I think this is one of many solutions to address this issue; commissioners we will talk about this more offline
