Question LJ: Can you provide us a plan during off-election season regarding outreach, education, planning and other elements of engagement of this civic duty and the next election

Question MDJ: I am appreciative of your department and the board of elections in your work and ensuring access to voting, I wanted to ask regarding the signatories. If people cannot sign their names, if that is done on a mail-in ballot, I think the public should know if that is the proper process. In the provisional ballots, you discussed 75 had missing signatures, does your office follow back up, can you explain electronic signatures, can you cast a ballot electronically?

Director Smith: You cannot. Likely an electronic signature that was printed and mailed in. I agree with what has been said about education and understanding the nuances of the process.

MDJ: please come back in about 3 months regarding your education

Question TT:I echo the sentiment of the committee, I appreciate your professionalism and diligence this election cycle. I want us to continue your enchantments with lowering wait times by advertising advance voting. Did you think the high number of advance voters is because of the new difficulties with mail-in voting?

Director Smith: A combination of a few things, the time allowed to complete the mail-in process within the law and because we are not in the hardest part of the pandemic and people are more comfortable coming out to vote

Question TT: do you see this trend continuing, how would that impact our equipment needs?

Director Smith: Yes I think that trend of advance voting will continue, we will be making assessments of equipment adjustments accordingly.
