JR: will assigning cases to a Hearing Officer be quicker than Magistrate Court? Yes but there still needs to be the ability to appeal to the Superior Court;

KG: Can we apply a Hearing Officer process that is focused on taking/suspending business licenses so that violators are shut down for a time

KG: We need a rewrite of ch. 25 and ch. 27 to bring harmony;

KG: Can we look at tools to incentivize compliance before appearing before a hearing officer?

KG: If we have a hearing officer finding that is to close a business, what power do we have to close/stop business? it could be implemented a part of new business licenses that you are subject to a hearing officer and their findings pending appeal;

SRB: who does the hearing officer report to? Independent

SRB: who hires hearing officers?

there is a pool of hearing officers available, they are paid by case through a non related departed like finance;
