-Question LJ: is there any way that you can have a satellite to do one big count instead of individual traffic counts?

P Keeter: I'm not aware of a program that does that, but that may be cost-prohibitive. These counts were based on best practices and discussions with people who do that.

-Question JR: the numbers you quoted didn't include Chamblee?

P Keeter: that's correct

-Question JR: your quotes included camera counts or two-counts?

P Keeter: it depends on the vendor; this would be once a year, and we would do the count locations once every 3 years. Additional information provided by Ms. Keeter.

-Question TT: was your recommendation to do these counts all at once or spread them out?

P Keeter: our recommendation is to spread them out for budgeting purposes

-Question TT: this may be a combination between Transportation and GIS working together. There is a map editor program, that I was introduced to who showed us how he built up his Waze editor credentials to view the traffic patterns. He suggested that we as a Transportation department could develop gateways arounds communities. It seemed like an opportunity to use technology and GPS to use those gates.

-LJ: I know ARC has Waze data, and would could schedule something to bring them. We can do this discussion quarterly to see how we have progressed. At a future update we could discuss that Waze data

-Question RP: it would be good to have initial baseline data for Unincorporated DeKalb that all commission districts could utilize then move from there

-LJ: if cities wanted to connect, it would be an idea for them to help pay. Something to think about and I'll leave that up to the committee

-P Keeter: based on the discussion it seems you are interested in doing the full GAAP analysis. I think we are in the \$40-50K range for the count. What we haven't done is identify the funding source yet

- -JR: successful public policy generates a widespread private response. I'm glad we're working to ensure the overlay is a catalyst for what people want to see in the area.
- -Question TT: one of the challenges of this area is that it's a challenging area; on paper it may look one way. Programming is something that has to be part of future development conversations. As we move forward looking at future development sites, thinking of those placemaking opportunities, but ways to introduce programming so that there is activity happening all the time.
- -LJ: Mr. White will you bring it back so we go through the deliberations?
- B White: yes sir it still has to go through the full process

That helps in terms of jobs being created, the proximity to home that people work, the associated business that is generated by additional housing created, etc.

- -TT: I'm interested in seeing that analysis for the major development. For the next report, I would like to see the value of a parcel before a permit/development, and how that next year's assessment changes. The tax digest is impacted by development. I would like to more clearly define the difference between parcel value and service delivery cost. We have to find a way to balance that equation in which suburbia does or doesn't pay for itself.
- -Question RP: as staff moves into Sams Street, I hope that you can track timeline of plan review to issuance. That kind of data would be very helpful. Do we have a phone call/email return time frame?
- C Hudson: We do have that; it's more on the operational side than the annual development report
- -Question LJ: can you work with Parks and Rec to tie in wellness in the report to see when you build a house, how it can impact the quality of life?
- C Hudson: we can definitely reach out and have that discussion
