- -Question JR: we're interested in seeing what the prospects are in our capacity to providing trauma care. Over the years I've always had that as a discussion item with hospital management at Emory. Secondly, I would like to have a discussion of this new investment in the fiscal plan of these hospitals that were former county assets, and now stewardship to Emory. Third, to see how our investments here in DeKalb are thought of within the larger context of our development with Grady Hospital as it relates to indigent care; would it be fruitful to discuss expanding the players in that relationship regarding the Grady Hospital Corporation.

- -Question MDJ: I support everything that you've said. I've also sat on the board of the DeKalb Medical. There's many issues that confront us; I don't think one shoe fits all. We have to learn to work together with our partners, understanding their goals as well as ours to get to the solutions for our communities. We need to treat trauma holistically; I support this idea, but it begs the question of how this relates to our strategy of a medical safety net in DeKalb County? I would like to see what the road forward is in bringing forward all of those players, and how these expenditures directly contribute to that. We should deal immediately with the request for ARP funding for the nurses, we could potentially look at the programmatic approach as it relates to trauma as an important first step of bringing Emory into the safety net network. I would also like to ensure we have exhausted the capacity for ARP for this. But I am ready to support the Grady piece, I would just like more information on the trauma piece.

Since I've been in
- office those decisions have been sound. With this crisis in front of us now, we're going to have to move to save lives. These are valid questions that Commissioner Rader has, but I think that this place is on fire, and its not due to Emory or Grady. After the CEO speaks I have a motion
