- -Mr. Gibson: eventually 6,800 jobs just for NBC Universal. 4,100 when they open day 1 in June
- -LJ: we will have to ask Doraville about the TAD when they are here, but you showed what the investment of the TAD will do -JR: what strikes me is that this is a different project than the TAD and its redevelopment plan that we originally approved in 2017. I'm interested in the process that Mr. Williams will bring to us that relates to the mechanism in itself. I hope that Central Staff can work with Mr. Williams to identify the mechanisms built into that, which were subsequently constructed with a community improvement district. There is a network of tax abatements in there that are working to fund this public investment. I want to be able to understand whether that redevelopment plan may need some updating in order for us to understand how those elements work and protect our interests and our increment in that way. I want to understand exactly what the County's interest is in this 10 year extension. For instance I see there is a fire station and other things that you've identified. Have you all discussed with the DeKalb County School System? They have wanted some sort of a convocation hall; it would be also great to see if we could get them into the mix of this TAD if we are going to extend it. What we have to deliver on is the updating of the public finance mechanism in a way that both is inclusive of all the stakeholders, and demonstrates what public value may spring from another 10 years of tax abatement on this. I hope that Central Staff can work with Mr. Williams to put teeth on those bones.
- -TT: what sticks out to me is the 20% providing affordable housing requirement to be met within the TAD. We have been discussing the need for more housing across income levels. What we're really missing and we need more of is 60% AMI and 30% AMI. I hope that we can work with Doraville and more of the authorities to carve out those opportunities for the middle to low income wage workers.
