These contracts consist of providing asbestos abatement, demolition, and debris removal services. This request is to exercise the 1st renewal option through December 31, 2023. Awarded to Southern Demolition, LLC, Kissberg Construction, LLC, and Diversified Environmental Management, Inc. Total Amount Not To Exceed: \$600,000.00.

- -Question JR: How many houses will the \$600,000 get us?
- -A Mitchell: I would saw about \$30,000 is a unit of 1; sometimes with multi-family projects of 4 you might get a break to do around 19,000 a piece. A minimum of \$20,000-\$30,000 for a single family home, and sometimes you get breaks when you have multiples 6 or 7. The low point is 20, the high point is 30.
- -Question JR: What is your target number of structures that you would like to take down?
- -A Mitchell: the target number for this year is about 50. Additional information provided by Director Mitchell
- -Question JR: do you expect this to be sufficient?
- A Mitchell: this would take us through a year-plus; additional information provided by Director Mitchell
- -Question LCJ: regarding the severity chart provided for properties that have a level 4 and 5, that would give us 280 properties that we have identified as being in need of demolition. With what you're requesting \$600K, that would allow us to demolish 20 properties. Is that 50 annually that we would like to demolish?
- -A Mitchell: In a fiscal year we are trying to do about 50; additional information provided by Director Mitchell
- -Question LCJ: with level 5 severity, they are not safe; in that category we have 103 properties. These are abated properties that have fallen under the care of DeKalb County correct?
- A Mitchell: I would say no; additional response provided by Director Mitchell
- -Question LCJ: how many properties do you have the capacity to abate if you had funds available to do so? Could we demolish 103 properties in the course of a year if DeKalb County could make available the funds?
- -A Mitchell: the timeline to do away with 100 would be longer that one year because of the variables in the process. Additional information on the in-rem provided by Director Mitchell
- -Question LCJ: Are we placing liens upon properties, if there is an owner willing to express responsibility? are we allowing owners who have accepted responsibility to demolish?
- -A Mitchell: Yes, the owner has x amount of days to take it down; if they do not then we will take it down. We always put a lien on properties with all the costs associated with that demolition. Additional information provided by Director Mitchell
- -Question LCJ: is it Cyclomedia that we use the technology to identify these abated properties?
- A Mitchell: Yes that is correct; additional response provided by Director Mitchell
- -Question TT: this represents to me a return on investments; by removing these pockets of blight this can help turn around the tax digest and that area will result in more tax revenues. Of those 600 properties that have been demolished or remedied, what is their status? Could we get an update on properties that have been demolished?
- -A Mitchell: The Land Bank could aggregate the costs and follow a foreclosure on those properties; to date we have not been able to go after the properties that have been identified or abated; we could with the right tools and the right lawyers that we use

Question TT: in terms of severity level 4 and 5, are any of those parcels already land bank-held?

Director Mitchell: no; the land bank currently have 7 properties. Additional information on the process provided by Director Mitchell
