Community Based Violence Intervention Plan (CBVIP) Grant

- -Question RP: since you're working with the Board of Education, will you be working with other jurisdictions?
- -Dr. Topalli: this is DeKalb County initially; additional comments provided by Dr. Topalli
- -RP: if there is a way I can help you engage with different police departments and mayors in District 1, I'd be happy to get you connected
- -Question LJ: regarding privacy, how will you deal with the privacy issue? They will still see us as government how do you build that trust?

- -Question LJ: what case management system provides the sustainability piece, that can tie in mental health and all of these programs?

- -D Furtado: Eddie Bocanegra, Senior Advisor, Office of the Assistant Attorney General is the director of the CBVIP program. We would like to invite him this summer to meet with you all for him to see what DeKalb is doing.
- -Question MLS: has there been any opportunities for renewal?
- -D Furtado: there was information from the Attorney General that there would be additional funding opportunities; they want to see a community violence interruption plan for DeKalb County
- -Question MLS: who would you be interviewing?
- -Cure Violence Global is one of our partners, they will provide the needs assessments based on their model, meeting with the community. Part will be focus groups, some interviews; we must connect and engage the community
- -Question MLS: regarding data gathering process, are you planning on getting this crime data from municipalities as well?
- -Dr. Topalli: we will be getting a lot of data from DeKalb PD initially, but we would be happy to expand on that based on our funding resources
