-Question T Hutchinson: the original amount awarded in this contract has been spent; the contract amount should be \$2 million which will eliminate me needing to come back to ask for another change order in the contract -Question TT: is the price point the same for the additional 14,000 roll carts? The \$2M will cover the 14,000? T Hutchinson: no sir; Z Williams: is this something we can hold for 2 weeks? T Hutchinson: this project begins in 2 weeks and a press release has been disbursed. This project lines up with the agenda item of \$1M. The additional \$1M is I will need additional carts until the expiration of this contract. Carts are coming in now; on January 25th crews will be on the ground swapping out 65 gallon carts for 95 gallon carts. This contract will expire August 21st. -Z Williams: in order to implement what has been advertised, are we able to do that? T Hutchinson: yes -Z Williams: then we can come back with a change order T Hutchinson: we order roll carts on an as-needed basis; we can't deplete the inventory and not have carts available for residents Z Williams: if we had to come back in 30 days we could? T Hutchinson: we could do that, and it would be quick -LCJ: is there a way to recycle or make money off the swapping out of these roll carts? T Hutchinson: old carts are shredded into small pellets that go in large bags. Shipped back to the plant in North Carolina to be used to make new carts; there is a small credit that we get from it. A shredder comes in a couple of times a year -Question TT: is recycling of the old carts in this contract? T Hutchinson: we work directly with the vendor to shred those carts. That is separate -Question RP: so we are getting 14,000 for \$1 million? LCJ: did the price of the parts increase? We may need a substitute to reflect 14,000 rather than the 15,000 shown T Hutchinson: the carts are a little bit higher in this change order. This is approximately correct regarding this project -Motion to approve TT

*RP:* Second, with friendly amendment to request that a substitute will be provided that explains line items of parts that will be received by the County, labeling, and distribution for the \$1 million investment

-C Horner: we have some improvements in the process that can possibly be made into the ordinance. Yesterday our new LSBE manager has started work here; she also worked with commissioners to write the LSBE ordinance in DeKalb County; we may reach out to you all for assistance.
