P Allen: no at this point there is no requirement to put those stabilizers in place. Additional information provided by Director Allen

-Question TT: as a policy to consider, does this contractor remove the plate when it's done?

P Allen: it does occur sometimes that the County may pick up a plate that has been placed by someone else, or vice versa. D Pelton: at the moment we're not part of CityWorks. I know that's something we want to be added in and have utility permitting adding in to better track what contractors are doing. We would have to see what GDOT's requirements are in that regard, because we cannot be more restrictive than GDOT. That is something we can check out.

-TT: we need to get the other contractors that aren't us on some sort of platform to verify the work was done correctly *-Question LCJ:* do we not have a system currently that tells us where these metals plates are located?

D Hayes: it is tracked in Watershed CityWorks. We are working with other departments to get them up to speed. We do place metal plates out with a work order and there are tracking of picking them up. We do not monitor contractors at this time.

-Question RP: if we took the \$440,000 and put it into a rapid reaction staff, is that feasible? To help us not rely on metal plates to begin with?

D Hayes: often these plates are put over a site because the work hasn't been completed. There is also the concern with getting asphalt in; asphalt contracts we often have a backlog because the vendors are busy and we can't pull them from one area to another.

-Question LCJ: would it be more conducive to bring on full-time staff as opposed to external source?

-Question TT: once a plate has been used, what happens to it? How often can you recycle?

P Allen: we take them to a designated area and hold them for future use

-LCJ: Mr. Grear could create a heat map on where these metal plates are. If there is an extreme case where we cannot procure materials, we should not have these metal plates out there for an extended period of time. I would like to see a mapping system of the tracking for these plates and tracking system for when plates are in the field for an extended period of time, such as 60 days

My concern is this contract is undercutting what could actually be done by our own paid staff. -LCJ: I would seriously ask that due diligence be given to making yard waste biweekly. It will allow us to be consistent in our service deliverv -information provided by COO Williams -Question RP: The County used to train CDL drivers; are we working on a process to train our own needs for the future? -response provided by Director Hutchinson -Question TT: I would like to see a plan for this to be in-house. How long will this emergency last? -LCJ: this is a ratification; the service has already begun. What will we do to address the root cause which is salary for the employees? -information provided by COO Williams -information provided by Director Hutchinson *-Question LCJ: where are we with the request for increase in pay* T Hutchinson: Arcadis is currently reviewing our revenue analysis; after that they will review a rate analysis and come back with a recommendation. Our revenue analysis meeting is this Friday -Question TT: the ERPS committee will gladly take up this salary compression issue, as it's currently in our work plan. We in the committee will work with HR to further enlighten everyone on how the salary compression works -LCJ: we are narrowing the scope of service. I'd like discussion on that -RP: there is an immediate short term crunch that is happening right now, that communities are having now. The issue now is that we need to get the services back up. I get a phenomenal amount of calls from residents related to pickup. This is a short-term alternative. I will support whatever it takes to get staff back to where it needs to be. When I hear from my residents, they want to have it fixed. Let's fix the issue, and that's what this approach is from my perspective -TT: if there's a shortage of trucks and drivers that is an issue. But this contract has nothing to do with that. We are getting landscape crews -Z Williams: we are anticipating us to get us through the contract; we are not sending the message that we are contemplating outsourcing. The labor shortage is present - we don't have the people. -Question TT: you don't need CDL drivers for the recycling. Why do we need it for yard waste? -response provided by COO Williams -Z Williams: if the committee wanted to ratify to the end of the year and have a strategy as part of the budget that's fine. -TT: it has been on the ERPS work plan to ask the question 'why would someone want to work for DeKalb County government'? What is it that we are offering job applicants? What is our competitive edge? Can we find out from our own employees why they work here, and what would make them stay if they were offered a different position elsewhere? If we do a survey analysis, then we could actively do job fairs -LCJ: that would have to be done in a more formal environment when COO Williams and Director Hutchinson would have time to prepare answers to these questions. But I do welcome this commissioner -TT: let's just approve the contract through the end of the year, and we ask the Administration what is the long-term strategy? -LCJ: if we're going through the end of the year on the ratification, it will take us until December and during that time you would bring a more detailed and comprehensive proposal that looks at pay and the best possible way at the most cost-effective way the delivery of service. Commissioner Terry is proposing to ratify the agreement for a 6 month period. That would require a substitute. COO Williams you're saving this money will be drawn down as needed and all of it may not be used. TT: I am less concerned about the price and more about the service that we could be doing in-house. So its more of a time period than the amount. Z Williams: we would come back during next year's budget cycle with any amendments and a strategy -LCJ: for those who provide our notes that are associated with the meetings, please indicate when there is a substitute and go ahead and write the 50% amount that's been requested, as well as the expiration date because that works better for me in my notes. Motion to approve a substitute agreement for a 6 month period from July 1, 2022 till December 31, 2022 and reduces the substitute amount from 1,950,000.00 to \$975,000.00
