American Rescue Funds

Watershed Management

-Question TT: Woodland Hills and Shepherd's Lane replacement projects, are they separate projects? Could you provide more information on that?

Z Williams: correct; additional information provided by COO Williams

-Z Williams: we are very cognizant of the impacts of inflation; the proposals that you'll see will not have impacts on residential

-Question TT: these are enterprise funds; if the rates haven't been raised in 10 years, and over the last several years we've seen the revenues erode. Is the concern that we're talking an extra \$30-\$40 to cover that? I don't see that in the Sanitation Fund we are deciding to eat those costs through other means?

-Z Williams : we will be bringing forward rate and revenue increases; they will be geared toward the landfill as opposed to residential. But we are not giving anyone a 'pass'. That plan will be coming to PWI in the coming weeks

-Question TT: it seems we will be raising rates on commercial vendors and the tipping fees. But the majority of costs come from the cans. Has there been an analysis done on the rate structure? There should be a dollars and cents analysis done that have to go into the enterprise fund that go into the long-term viability of the service. Will this \$10M forestall the residential increases for another year? How long will it forestall?

-Question TT: so we're not going to vote on ARP regarding Sanitation until you bring forward the plan?

Z Williams: that's correct, and that's why we wanted to hold this conversation for today

-Question RP: what are the discussion points for any increases, and how is that being a benefit to our residents? Inflation has had an impact on people; there has to be a strategy so that the taxpayers are seeing their needs are being addressed.

If there's a way to come back with that data to show the residents the value they are getting R Lemke: certainly -Question TT: we get asked often 'where does the recycling go'? I've actually never seen it. You mentioned we used to get money for this and now we are spending money. Pratt has been our taker for how many years? R Lemke: it goes back to 2012 -Question TT: so Pratt used to give us money? R Lemke: yes; additional response provided by Director Lemke -Question TT: what is the rationale for us having a fee structure regarding recycling? Not everyone opts in to the service R Lemke: in DeKalb recycling is a voluntary program, not everyone is obligated to do that. The participation is excellent, and they do a great job of providing the recycling materials for us to put in -Question TT: regarding our subscription rates, is it 40% opt in for the recycling cart? *R* Lemke: I believe that's correct, I'd have to go and look at the numbers -Question TT: those that are choosing not to opt in are paying the same amount, so it's really a use it or lose it situation R Lemke: right -Question TT: as we look at increased costs and reviewing the system through the lens of equity; we have a population that are paying for others to use recycling; we are paying for it if we are not using recycling -response provided by Director Lemke -Question TT: does Pratt pick up glass recycling? *R Lemke: I'd have to look that up for you* -Question TT: I think that as we move forward we should consider how we can leverage the local glass manufacturing facility, to increase the life of the landfill, and we can increase intake and hopefully encourage other facilities to do so. Glass makes it harder to sort at recycling centers? *R Lemke: that's correct; additional response provided by Director Lemke* -Question TT: so we're approving to extend the current contract at the current rate?
