### ARP Tranche 2 - Infrastructure Projects

Question LCJ: are these projects apart of PSARP?

Hayes: No, PSARP is for sewer these projects deal with drinking water systems. System is about 50-60 years old. This is a part of our ongoing New Day project

LCJ Request: Send list of pipe replacement priorities as part of the 2019 Stormwater Masterplan, with completed items highlighted in green and rest organized by highest priority.

*Question TT: is there thoughts of re-evaluation based on the 17 watermain breaks over the holiday weekend? How do these recent break events fit in?* 

Hayes: It wont impact the list. This was an anomaly due to the cold weather snap, this affected a huge area of the southeast region. *Question TT: Are there any weatherproofing efforts? Are new pipes expected to withstand more extreme weather* 

Hayes: We are aiming to stop being reactive and use the ARP funds to be proactive in our watershed system. The national average in a yar is about 300 miles/year in a given area.

Question TT: What is our plan of action for communication response to stakeholders when events like this occur?

COO Williams: Staff reacted quickly to this event, we recognize our communications system needs updating and a review will occur to see what changes could be made

Question LCJ: Who manages Code Red?

COO Williams: It is internal with Emergency Management

*LCJ:* Please bring in the director of Code red to an upcoming PWI meeting to walk us through the communication process. What we currently have and opportunity to provide feedback.

COO Williams: I'd recommend we bring this to ERPS, because it's through emergency management and covers weather events, among other things

Question TT: Do we have contractors for these projects already?

Hayes: yes, they are on contract, if approved we will release them to get started
