Question MDJ: regarding operating supplies request \$125,755, why is recommended lower?

Sigler: I believe that request is looking at the total for the year, we lowered it to provide funds for the remainder of the year. Additional comments provided

Question TT: I have questions about the police budget. We have vacancies in the department, are they getting re allocated? Sigler: The police did have a request of 1,125,566 for a variety of positions. All of that is recommended in their existing budget. The budget can absorb the costs without additional funds allocated.

Question MDJ: This is an extension of the contract, why are you extending?

Director Ransom: Correct. We went through a bid process and a new vendor has been identified, this is extending out the rest of the year. Ouestion TT: How many employees a year are tested?

Ransom: all new hires are tested and random testing for DOT Compliance. As of this month we have 1561 people for drugs and over 300 for alcohol. Anyone who holds a CLD has to be tested periodically.

Question TT: What about non safety sensitive positions?

Response provided by Director Ransom

Question TT: the roughly 2000 office jobs, once they are screened and hired they are no longer tested.

Ransom: Correct. We do a pre employee physical which includes a drug test.

TT: I'm getting different messages from you and some employees who are claiming they are being actively testing. Can you please provide the specific policy.

Additional information from Human Resources Staff provided

Question TT: Non safety employees can still be tested with reasonable suspicion; What is the concern for reasonable suspicion?

Ransom: If at least two supervisors have concerns for an employee coming to work intoxicated they can be sent for reasonable suspicion testing.

Question TT: I do want to point out this is now a medical marijuana state now. Low THC is allowed under the law that however can be picked up by testing, correct?

Ransom: Correct

Question TT: Why do we have this policy for employees when we now know medical marijuana is available and that it stays in the system long term.

Ransom: it is a challenge, we are going to be working with law about the issue.

TT Request: keep us updated on that review

County Attorney: That may be harder due to the infrastructure required. Additional comments provided by County Attorney Question RP: I believe we have an ordinance requiring ICC Inspector report, that is typically where you would see that information.
