Q TT: What I'm hoping is that we get agreement today that we should get full coverage of every district with an outreach team. Would it be okay to withdraw this item, if we make a recommendation requesting the administration comes back with a plan of full county-wide coverage with an outreach team by first quarter 2026 and funding through the budget? I want each district to be full covered. I would suggest this be a county wide priority, and not pieced together through induvial commissioner appropriations.

COO: I believe the policy statement that you are looking to make is that homelessness outreach is important function of the County and that you are requesting through the CEO's 2026 budget is sufficient coverages provided to accomplish that. Whether that is through the outreach team or supported by the team and contractors, that is the expectation you would like us to come back with.

Q TT: and that if any of the outreach team members want to opt in to a benefits package? The budget impact is relative minor per individual.

COO: So the policy statement and options prepared to fund benefits. We can work those details out.

TT: I would like to so move that statement and compromise

Q RP: is it possible this will end up in the budget? If so would it be prudent to hold it in committee Q TT: the committee makes the recommendation, we are asking the CEO to include the funding of full coverage or street team employees, the number pending and to include benefits.
