APPROVAL OF AGENDA

Chair Swift called the Board of Registration and Elections meeting to order at 4:40 p.m.

Ms. Austin conducted the roll call, confirming the presence of each board member by name. A quorum was established.

Ms. Lee moved to amend the agenda to include discussion of a brief review of the County's procedures for the removal of convicted felons and compliance with Senate Bill 189. The motion was seconded by Mr. Bowden. Upon a vote, Ms. Lee and Mr. Bowden voted in favor, while Ms. Lowman, Mr. Abhiraman, and Chair Swift voted in opposition. The motion failed.

Ms. Lowman inquired whether the proposed discussion items could be included on the next month's agenda. Ms. Lee agreed to do so.

A motion to approve the agenda as presented was made by Ms. Lee and seconded by Ms. Lowman. The motion passed unanimously.

APPROVAL OF MINUTES

A motion to approve the minutes of the September 10th meeting was made by Ms. Lowman and seconded by Mr. Abhiraman. The motion passed unanimously.

PUBLIC COMMENT

Ms. Austin read the rules for public comment:

Public comments may be made in person or submitted by sending an email of one printed page or less at a minimum font of 12 to electionspubliccmnt@dekalbcountyga.gov which must be received between 35 and 5 minutes before the scheduled start of the meeting. The body of your email must include your first and last name. By submitting an email for public comment, you agree to have your name and the email broadcast on the UStream and entered into the record and minutes. The DeKalb Board of Registration and Elections reserves the right, at the DeKalb Board of Registration and Elections' sole discretion, to (1) add your email to the record/minutes without reading any of it into the broadcast or (2) read all or a portion of your email into the record/minutes. All public comments will be limited to 2 minutes. Abusive, profane, or derogatory language, holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.

ITEMS FOR DISCUSSION

A) Director's Report

Director Smith reported on voter registration activities and reviewed the registration numbers provided in the board packet. She went on to thank the registration team for completing the backlog of applications the office received during processing hold period. Director Smith then provided election activities and reported on individuals who would not be listed on the ballot including two candidates who withdrew since the previous board meeting as well as the candidates the Board voted to strike from the ballot last month due to disqualification. She went on to state that the elections staff completed ballot proofing and notified candidates of the review period. The final sample ballot is posted to the website and absentee by mail ballots are scheduled to be mailed on October 14, 2025.

Director Smith provided an overview of budget updates located on page 12, noting that poll worker and temporary employee salaries, equipment purchases, and other project-related

expenditures have been appropriately accounted for and remain on track to meet year-end financial targets.

An update on communications efforts was also provided, emphasizing that inactive status does not mean ineligible, and reminding the public of the upcoming November 4, 2025, election date. Director Smith noted that educational materials have been distributed throughout various areas of the County.

Earlier in the week, a joint party meeting was held with members of the Republican and Democratic Parties, including Board Member Bowden. Bringing the party leaders together before each election is a DeKalb County tradition and fosters an open dialogue about collaborative efforts to facilitate fair, free, and accurate elections.

Director Smith also reported that external and internal training initiatives continue to improve and highlighted a recent staff retreat held over a day and a half, which provided an opportunity for staff to step away from daily operations and focus on building a stronger, more connected, and higher-performing team.

Two new additions to the staff were announced: Mr. Tejeswara Reddy, who is completing a nine-month residency as part of his graduate coursework at Georgetown University, and Dr. Jesse Harris, the new Deputy Director of Public Affairs and former Deputy Director, Elections Services & Administration with the Georgia Secretary of State.

Ms. Lee inquired about the number of felons on the list; Director Smith responded that there are 1,551. Ms. Lee further asked whether the ballot would be front and back. Director Smith stated that voters would receive their specific ballot – not the full sample ballot which is a composition of all contests across the county. If voting in person the ballot is accessible on the touch screen, allowing voters to view their full ballot before printing.

Ms. Lee also asked about the budget, specifically noting that there were no line items for Group Insurance or Pension. Director Smith explained that those line items are managed by the County Finance Department. Ms. Lee then asked whether those expenses are reimbursed by the Voter Registration and Elections (VRE) budget, and Director Smith confirmed that they are.

Mr. Bowden asked whether there had been any workers' compensation claims filed. Director Smith responded that she was not aware of any. Mr. Bowden then inquired about the Professional Services line item. Director Smith clarified that it includes expenses for movers and consultants supporting operations and voter services. Mr. Bowden thanked Director Smith for the clarification.

Chair Swift requested that a budget session be held offline for Board members and commended Director Smith and the department for remaining under budget.

B) Pre-Certification Meeting || Municipal General/Special Election

The Board scheduled the Pre-Certification Meeting for Friday, November 7, at 9:30 a.m.

ITEMS FOR DECISION

A) Approval of Poll Managers

Ms. Lowman inquired whether there is a way to obtain information regarding poll manager turnover. Director Smith responded that such a list could be provided.

Ms. Lee asked whether poll managers could be appointed from both political parties. Director Smith explained that the previous Board had voted to remove party designation from the poll worker application. Therefore, that information is no longer collected or available. Director Smith further stated that applications are welcomed by all.

A motion to approve the list of poll managers was made by Ms. Lowman and seconded by Mr. Abhiraman. The motion passed unanimously.

EXECUTIVE SESSION

No executive session was convened.

BOARD COMMENTS

Ms. Lowman thanked the staff and department management for their efforts during these challenging times. She then addressed a public comment made online regarding convicted felons stating that no county initiates the removal of felons and that there is an established process for that activity and elaborated on that. She went on to state that the department adheres to the established process and acts accordingly.

Mr. Bowden expressed appreciation to the new staff members and to the audience for their attendance.

Mr. Abhiraman extended thanks to the staff, and both returning and new attendees.

Chair Swift thanked the staff and audience members for attending.

ADJOURNMENT

At 05:27 p.m. a motion to adjourn was made by Mr. Bowden. Seconded by Ms. Lowman. The motion passed unanimously.

APPROVAL OF AGENDA

Chair Swift called the Board of Registration and Elections meeting to order at 9:47 a.m.

Ms. Austin conducted the roll call, confirming the presence of each board member by name. A quorum was established.

A motion to approve the agenda was made by Mr. Bowden and seconded by Ms. Lowman. The motion passed unanimously.

PUBLIC COMMENT

No Public Comments

ITEMS FOR DISCUSSION

A) Director's Report

Director Smith Director Smith stated that VRE staff had compiled a pre-certification report in accordance with SEB Rule 183-1-12-.12, which requires the Board of Registration and Elections to hold a meeting after Election Day for the limited purpose of conducting a review of precinct returns. She went on to present a summary of the unofficial and incomplete pre-certification report. The Board reviewed the summary.

Chair Swift asked how the report was tabulated and inquired how the 31% voter turnout compared to previous years. Director Smith responded that the department would review historical data and provide a follow-up.

Ms. Lee stated there was no evidence of widespread ballot issues and asked several questions, including whether there were any ballot style or chain-of-custody issues, any incidents of fraud that required referral to the District Attorney, and how voter wait times compared across locations. Director Smith responded “no” to all of these questions and elaborated that wait times were not significant.

Ms. Lee also asked if there were any disruptions at polling places or voter complaints. Director Smith confirmed there were none. When Ms. Lee inquired about the transportation of ballots during early voting, Director Smith clarified that ballots were securely transported in full compliance with Georgia state law.

Ms. Lee further asked how many voters participated in the City of Atlanta election between 7:00 p.m. and 8:00 p.m. on Election Day. Director Smith responded that the department would identify and report that figure.

Mr. Bowden requested an explanation regarding the City of Atlanta election. Director Smith deferred to the legal team, and Mr. Petty went on to provide an explanation of the statute in the Georgia law regarding the 8:00 p.m. closing time.

Director Smith subsequently reported that 42 voters cast ballots in the City of Atlanta between 7:00 p.m. and 8:00 p.m. She further noted that historically, the early voting process had an error rate of 0.1%, while the current rate stands at 0.02%, which may decrease further upon completion of canvassing. Director Smith then commended the Voter Registration and Elections staff for their continued commitment to operational excellence.

Chair Swift concluded the meeting with closing comments from the Board.

BOARD COMMENTS

Mr. Bowden thanked the Voter Registration and Elections (VRE) staff for thoroughly answering his questions and expressed his appreciation for their work.

Ms. Lowman stated that this meeting provides valuable transparency into the election process and expressed her gratitude to Director Smith and the VRE team. She shared that she personally had a great experience and received positive feedback from others and went on to express being pleased with the voter turnout.

Ms. Lee thanked the VRE staff and management for their hard work and long hours, and for providing detailed information throughout the process. She also extended her appreciation to the poll managers, poll workers, and members of the public in attendance.

Mr. Abhiraman commented that he looks forward to the day when these types of meetings will no longer be necessary.

Chair Swift expressed her appreciation to the VRE staff, poll workers, and managers, noting that the strong training program is a testament to their dedication and professionalism. She observed that voter turnout for this election was double that of the previous municipal election. Chair Swift added that while this meeting serves a procedural purpose, it does not represent the final results but rather the preliminary data. She stated her concern that the State Election Board's requirement for this type of meeting may inadvertently contribute to misinformation and hinder staff effectiveness. Chair Swift urged that the next legislative session take action to address this issue. She concluded by thanking everyone who attended the meeting in person and those watching online, and noted that the Board looks forward to reconvening on Monday once the tabulation process is complete.

ADJOURNMENT

At 10:10 am a motion to adjourn was made by Mr. Bowden. Seconded by Ms. Lowman. The motion passed unanimously.

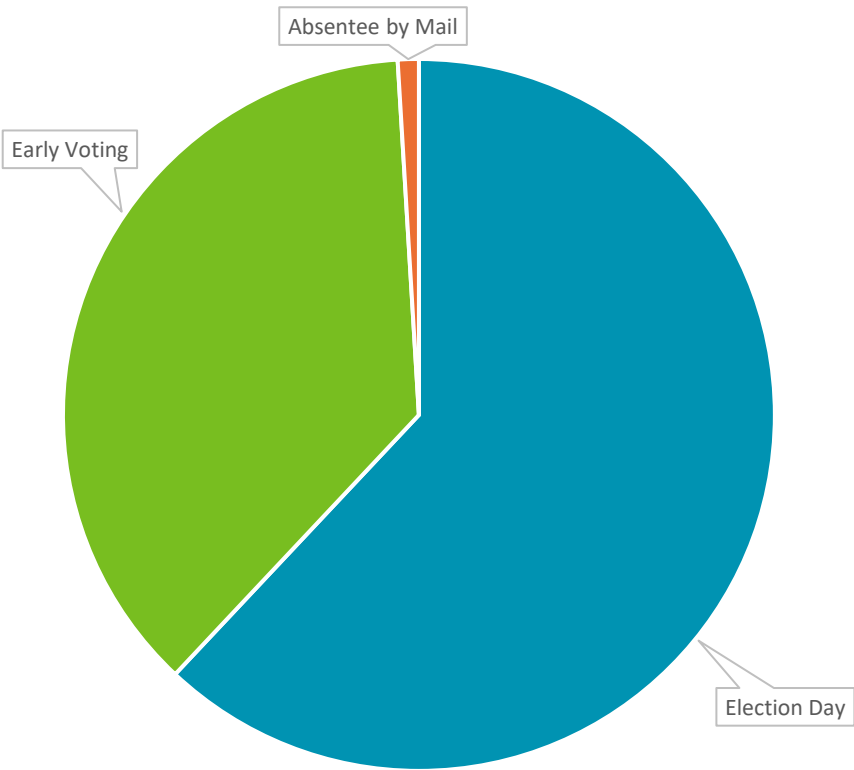

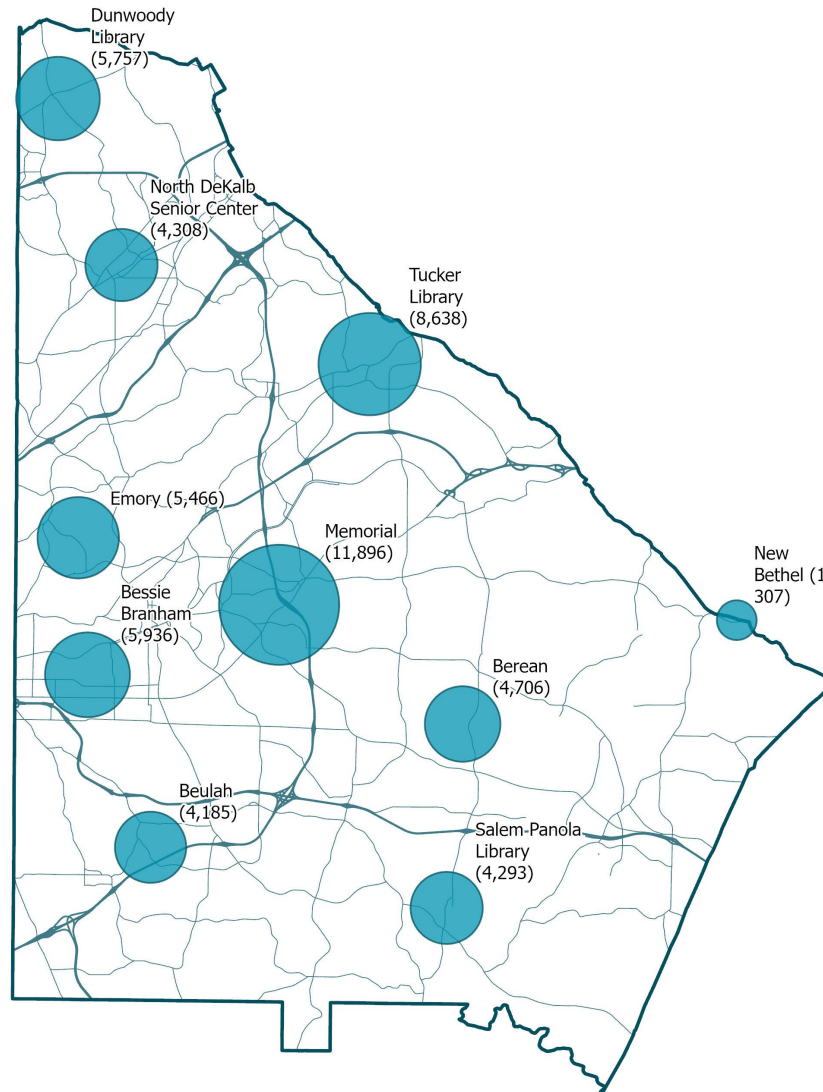

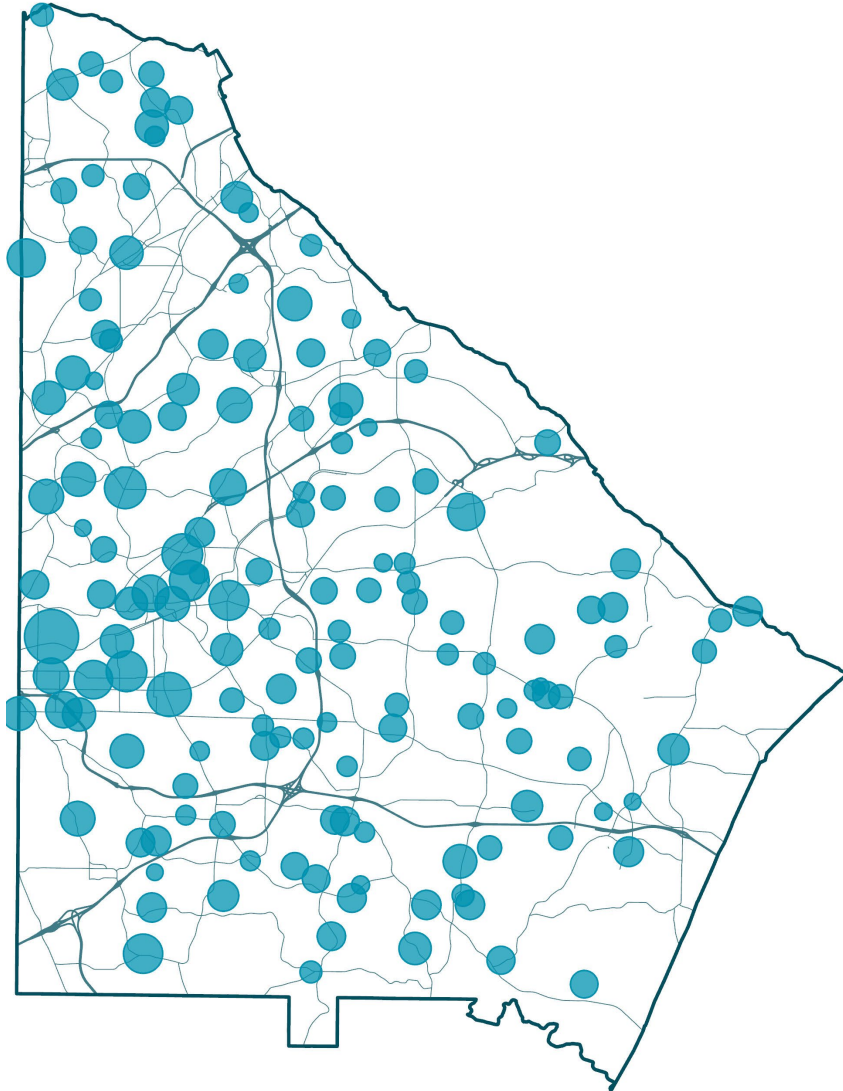

At the conclusion of the hearing, "the registrars shall determine said challenge and shall notify the parties of their decision." O.C.G.A. § 21-2-229 (d).

Because of this evidence that Ronald Van Leaks is no longer a resident of DeKalb County, we request a prompt decision. We are prepared to provide witnesses, if necessary, to testify that Ronald Van Leaks no longer lives at the address listed. In the meantime, we hope the receipt of this letter begins the prompt removal of Ronald Van Leaks from the DeKalb County list of electors.
