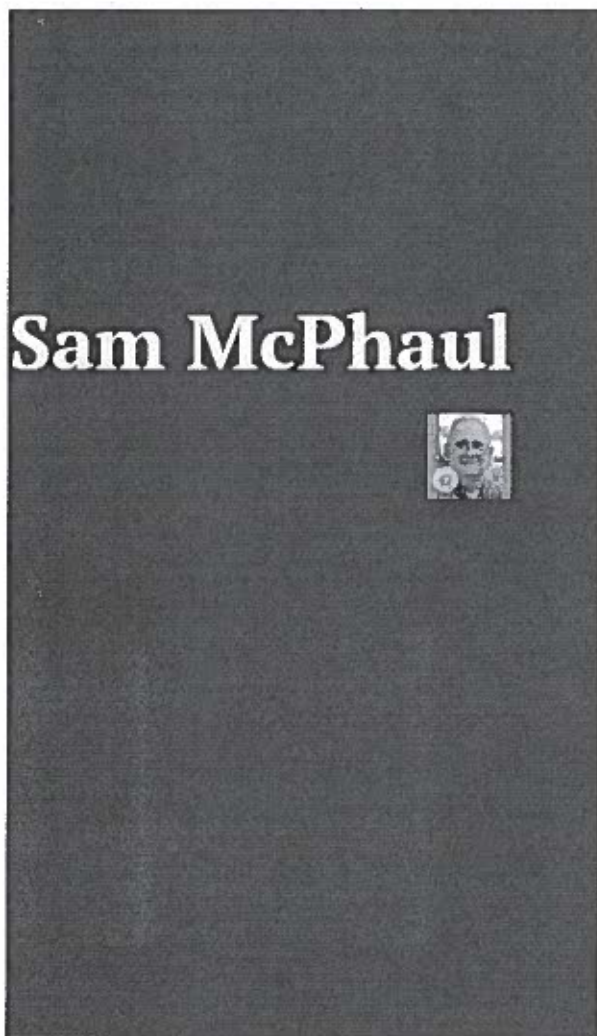

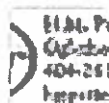

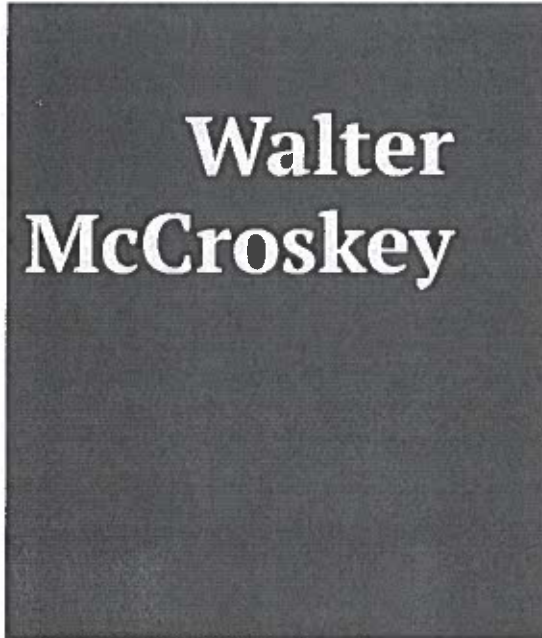

HILL RANDOLPH HEALAN, SR. May 26, 1915- July 5, 2006 Hill R. Healan died at age 91 of lung complications. In the post-war years Hill began a life-long career in local and state government during which he held administrative positions with both the Atlanta Junior Chamber and Chamber of Commerce and served as City Manager for the cities of Cordele and Griffin and later Meridian, Mississippi. He served as Executive Director of the Association of County Commissioners of Georgia for 25 years, where his service as a leader, planner, and organizer set the standard for county government nation-wide. A disciplined diabetic for almost 60 years, Hill's genuine enthusiasm and joy of living knew no boundaries and touched many. He served as President of the Judson C. Ward Sunday School class at Glenn Memorial United Methodist Church. He loved playing checkers, and was a national tournament player and champion. He also loved music, gardening, astronomy, and Native American history, but he loved his wife of 66 years, his children, grandchildren, and great-grandchildren more than anything else in his long and prosperous life. 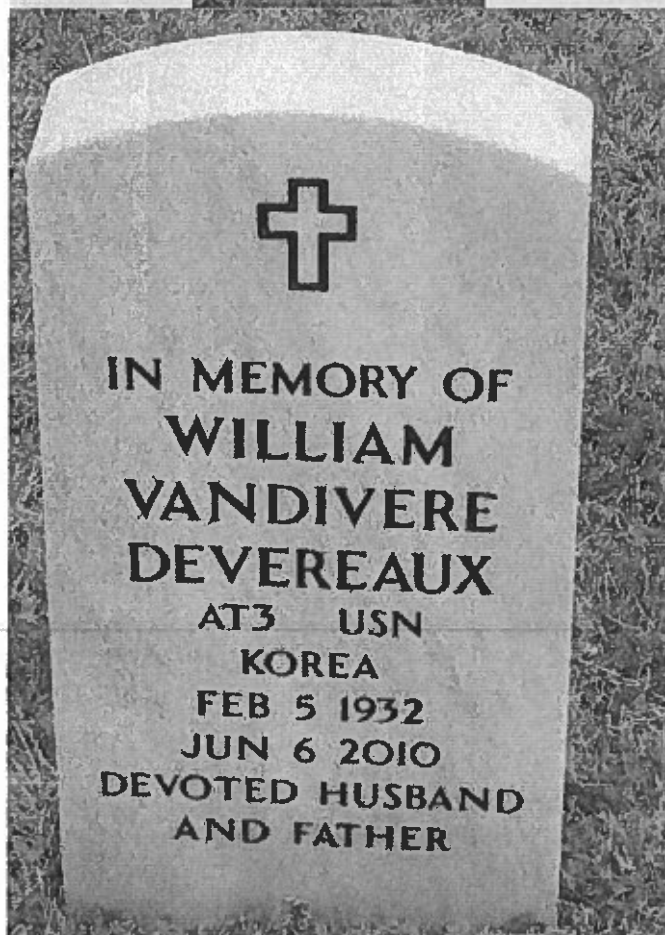


