RISK-LIMITING AUDIT RESULTS

Risk-Limiting Audits

On November 13, all Georgia counties conducted a Risk-Limiting Audit (RLA) of the Public Service Commission District 2 contest. An RLA is a hand audit of selected ballots designed to demonstrate that the outcome of the election has been declared correctly. DeKalb County tallied a sample of batches selected at random by the State and its partner, VotingWorks.

Batches Counted

ABSENTEE BY MAIL ICC 1 - 16	50 ballots from the 16 th batch scanned on the first absentee tabulator.
ED-FLAT SHOALS PARKWAY	600 ballots cast at the Flat Shoals Parkway Election Day polling place.
ED-KELLEY CHAPEL ROAD	262 ballots cast at the Kelley Chapel Road polling place.
ED-MATHIS-BOB MATHIS ELEM	596 ballots cast at the Mathis-Bob Mathis Election Day polling place.
ED-MCLENDON	687 ballots cast at the McLendon Election Day polling place.
ED-MILLER-ELDRIDGE L MILLER ELEM	433 ballots cast at the Miller-Eldridge L. Miller Election Day polling place.
ED-STEPHENSON HIGH	588 ballots cast at the Stephenson High Election Day polling place.
PROVISIONAL ICC - 11	2 ballots from the 11 th batch scanned on the provisional tabulator.

Results

In general, a slight margin of error can be expected in a hand count. However, in this case there were no discrepancies.
