Subject: Peachtree Boulevard Water Transmission Main Replacement Project Begins July 7

Greetings,

As part of DeKalb County's \$4.27 Billion Capital Improvement Program, the Department of Watershed Management (DWM) will be improving the capacity and service of the Watershed systems serving your community. The **Peachtree Boulevard Water Transmission Main Replacement Project** has been designed to improve the watershed system in your community.

This letter serves as formal notification that construction activities with this project will begin **Monday**, **July 7**. Normal construction hours will be from **9 a.m.** to **4 p.m.**, **Monday through Friday**, **excluding major holidays**.

Please be advised to expect an **increase in construction-related noise and traffic** during work hours. Property/business owners will be notified **48** to **72 hours** prior to the start of impactful construction activities. Our construction crews will work persistently to minimize the length of impact to businesses, residents and motorists.

Crews will replace approximately 11,000 linear feet of an existing 30-inch carbon steel main with a 36-inch ductile iron main. Crews will also remove the 8-inch and 6inch pipes running alongside the 30-inch and replace them with 12-inch pipe. Work will begin on Malone Drive, the southern end of the project. Crews will then move to the northbound lane of Peachtree Industrial Boulevard and continue north until completion on Carver Drive. This watermain replacement project is expected to last approximately two and a half years (July 2025 to January 2028), barring any weather delays.

**Ruby Collins**, working on behalf of DeKalb County, is the authorized contractor for the **Peachtree Boulevard Water Transmission Main Replacement Project**. All workers will be wearing proper identification.
