Small Area Plans

One of the primary tools to guide development within Activity Centers is through the use of Small Area Plans (SAPs). These plans allow policy makers and the community to guide development, policies, and investments at a much finer level of detail than can be provided in the comprehensive plan.



Stone Mountain PATH Trail

The Stone Mountain PATH Trail SAP was selected as one of five recipients for the 2023 Community Development Assistance Program (CDAP.) DeKalb County will receive a project grant to assist in developing a two-year master plan for an area along the Stone Mountain PATH Trail.

This project will bring together cross-jurisdictional stakeholders to help align planning goals and regulations to create more affordable housing, multimodal transportation options, and places for the community to work and play.

The next steps of the project include a Scope of Work verification meeting with ARC, contract signature between the two parties, and procurement in early 2024.



Presidential Pkwy/Embry Hills

DeKalb County Planning and Sustainability is moving forward with a Arts & Culture study for Presidential Pkwy/ Embry Hills. The Presidential Pkwy/ Embry Hill study will include an analysis of existing conditions that impact the ability to create a livable, pedestrian friendly environment associated with the boundary of the study.



Goals and conditions regarding Small Area Plans and other DeKalb County Planning and Sustainability projects can be referenced in the DeKalb 2050 Unified Plan.

Memorial Drive Revitalization



Memorial Drive Tour

Representatives for Senators Ossoff and Warnock, Congressman Hank Johnson, Commissioner Bradshaw, Decide DeKalb, DeKalb Chamber, Lexicon Strategies, and the Planning Division took a tour along the Memorial Drive corridor on February 22nd to view the rebranding efforts soon underway. Each playing a vital role in revitalizing the Memorial Drive Corridor.

Memorial Drive Rebranding

Part of the Memorial Drive Revitalization Plan is for the re-branding of the corridor. DeKalb County is collaborating with Houser Walker Architecture to reimagine Memorial Drive and create a logo that represent the corridor. The logo was publicly presented on June 8th, the Final Public Meeting of the Memorial Drive Rebranding Initiative. A recording of the meeting is available <u>here.</u>

The primary goal of the Memorial Drive Revitalization Plan is to provide a vision for the area. Work towards a consensus among business owners and the community. Create a revitalization strategy for this important corridor that includes beautification, vibrant businesses, mixed use development, and living wage employment opportunities.

Trees and Trails

Trees and Trails have partnered with PATH Foundation to create a trail study for a trail to connect the Indian Creek MARTA to Memorial Drive. They had their first public meeting on May 22nd, 2023.

Plans to create a Community Development Corporation as well as a website to inform, educate, and gather community feedback.

Community Action Groups

Since the Memorial Drive Revitalization plan's adoption, DeKalb County has been working on numerous plan initiatives. The Community Action Groups (CAG) is designed to be the community advocacy needed to move the needle on various projects.



Transit Oriented Development

Transit-Oriented Development, or TOD, means development that is vibrant, pedestrian-friendly, and genuinely integrated with transit that supports both local community development and regional economic development.

Kensington Station

In June 2022, MARTA and DeKalb County began the TOD master planning process with an interactive website, community meetings, and stakeholder engagement. The goal of the master plan is to direct the rezoning of the property and to enable its redevelopment from the private development community. In early May 2023, the DeKalb County Board of Commissioners approved the rezoning effort allowing MARTA to continue work on the Kensington Station TOD.

DeKalb County Planning and Sustainability are working with MARTA to plan and implement Tactical Urbanism at Kensington station to promote walkability and safety for pedestrians.

Indian Creek Station

Indian Creek Station TOD Master Plan is underway! This project will create a community-driven plan to catalyze the transformation of MARTA's Indian Creek Station into a walkable, vibrant, mixed-use, transit-centric community.

The Indian Creek Station Transit-Oriented Development (TOD) Master Plan is an opportunity to transform this endof-line station into a transit-oriented community that connects people to opportunity, drives sustainable community development, and promotes regional prosperity.

On May 11th, 2023, MARTA hosted a community workshop that invited the public to influence the master plan and provide input in an open house format.
