NOTICE 1: This form must be completed and submitted to the Planning & Sustainability Development Services before a permit(s) is issued. This certifies **all** work done by owner on one Residential project. All information requested on this form is mandatory in addition to a completed and signed permit, for each permit type, indicated below.

Nothing in this chapter shall preclude any person from constructing a building or structure on real property owned by such person which is intended upon completion for use or occupancy solely by that person and his or her family, firm, or corporation and its employees, and not for use by the general public and not offered for sale or lease. [Georgia Code, Title 43, Chapter 43-41-17(h)]

NOTICE 2: The State of Georgia licensed contractor must pull all construction permits by law. However, a homeowner is allowed to pull a construction permit to build their home every 2 years. All other permits (Mechanical, Electrical, Plumbing, and Gas) require the State of Georgia licensed contractors to pull their individual trade permits.

Applicant further affirms that he/ she is aware that any knowingly false statement made in the permit application may subject, said "Applicant," to prosecution for violation of Georgia Criminal Code, Section 16-10-20 (False Swearing) and a possible fine of not more than \$1,000.00 or imprisonment for not less than one (1) or more than five (5) years, or both.
