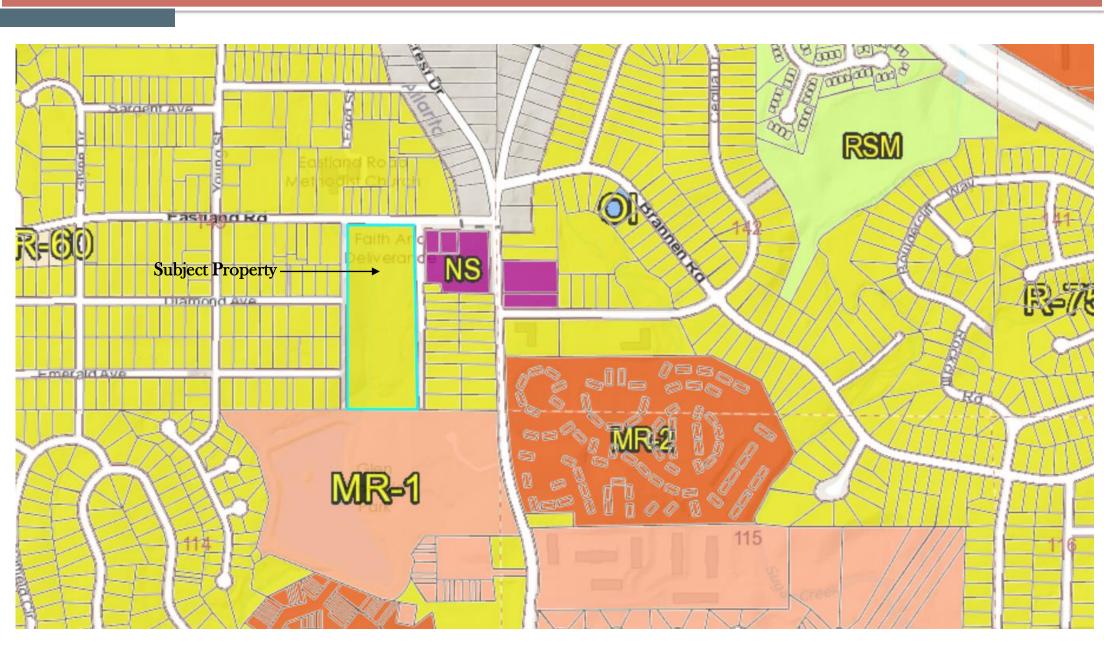

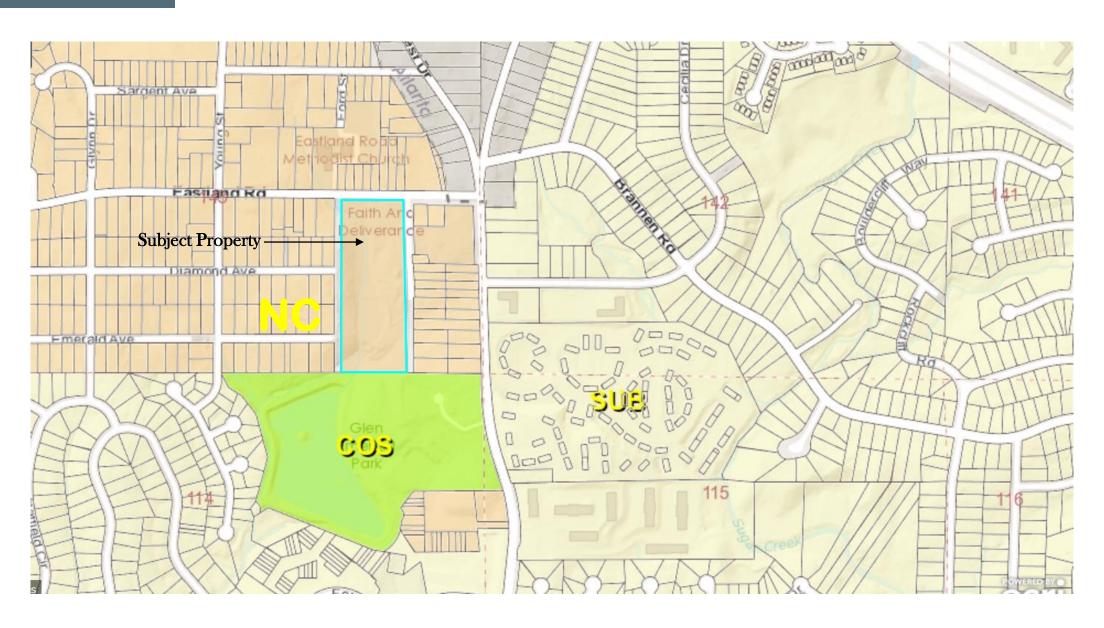

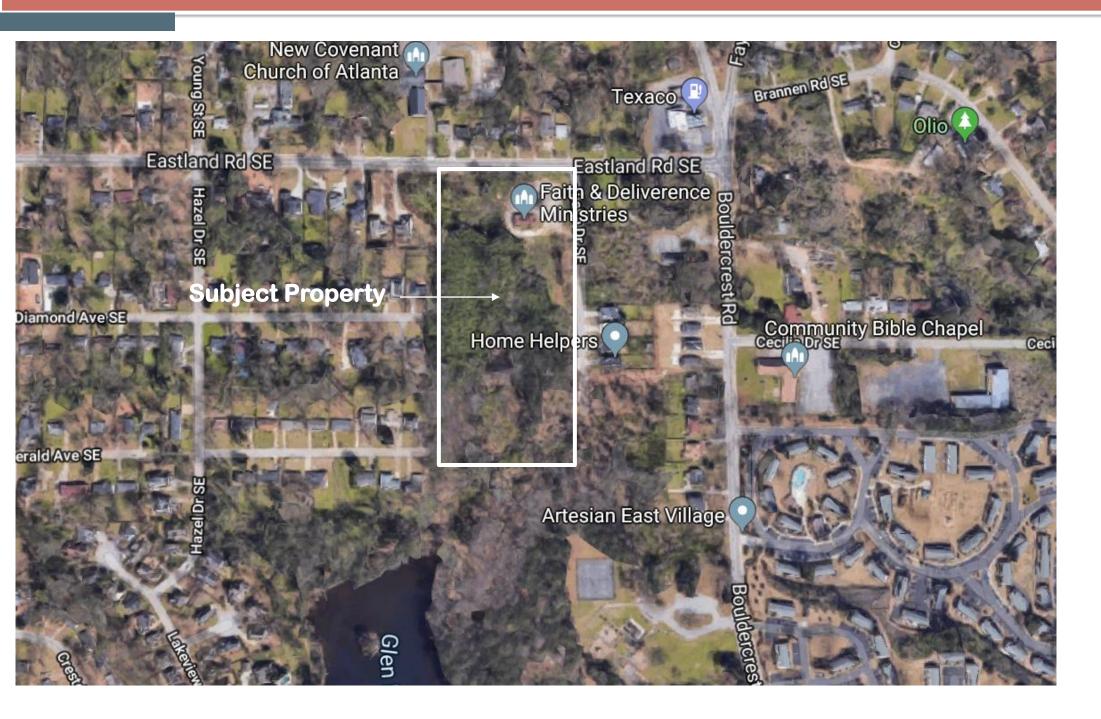


N. 5 Z-19-1243381 Zoning Map
