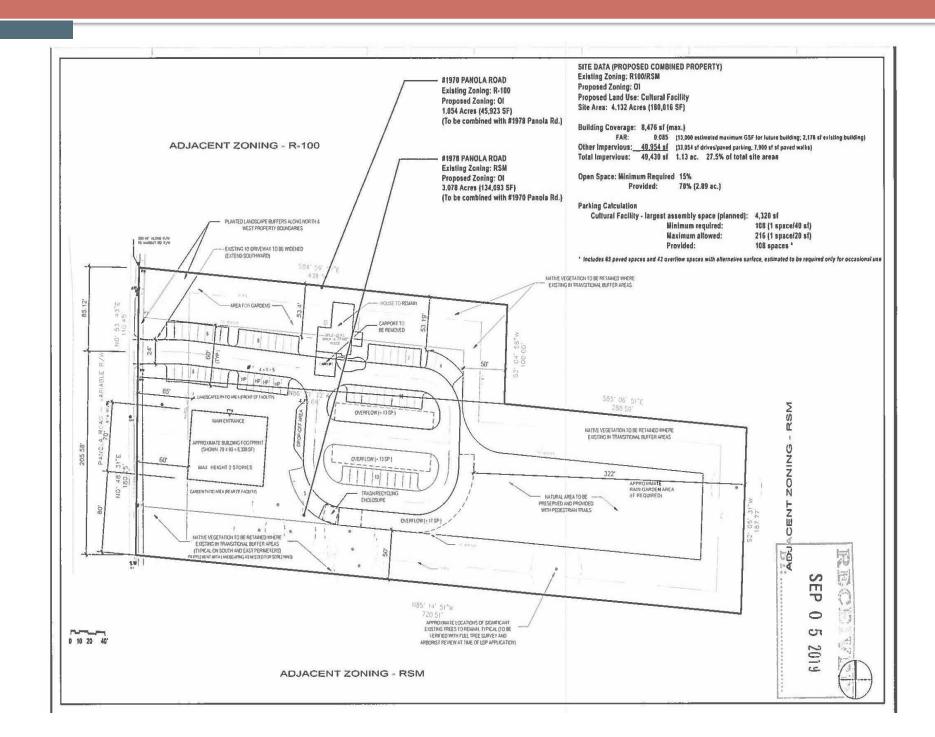

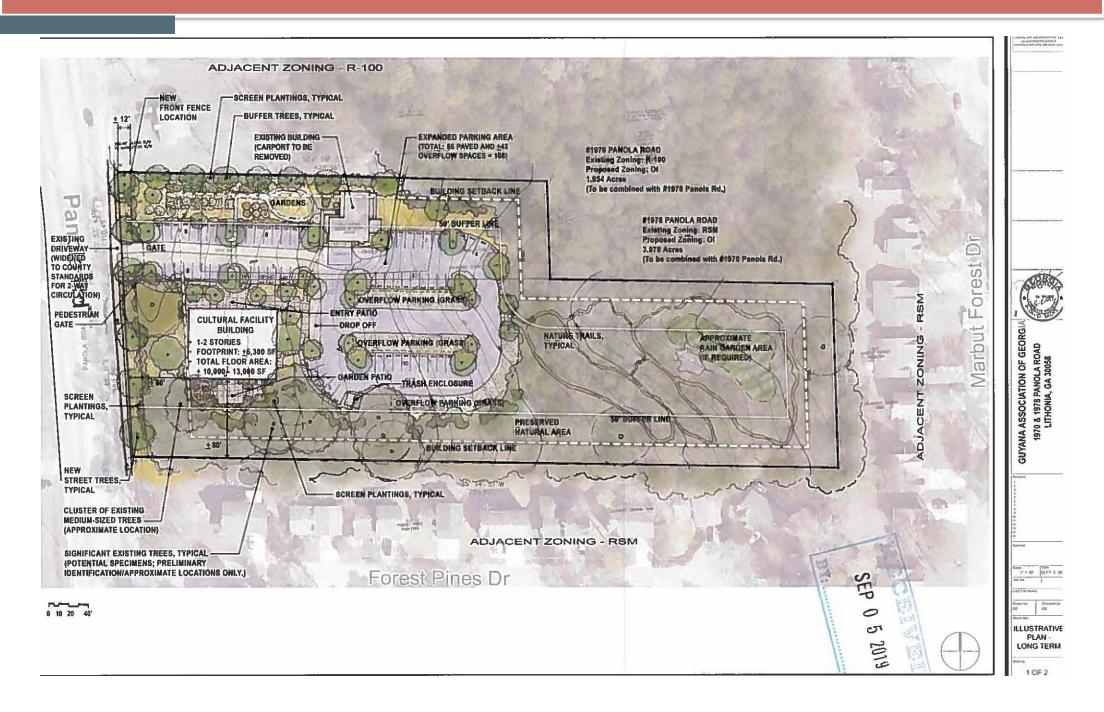


Z-19-1243514 Short-term Landscape Plan



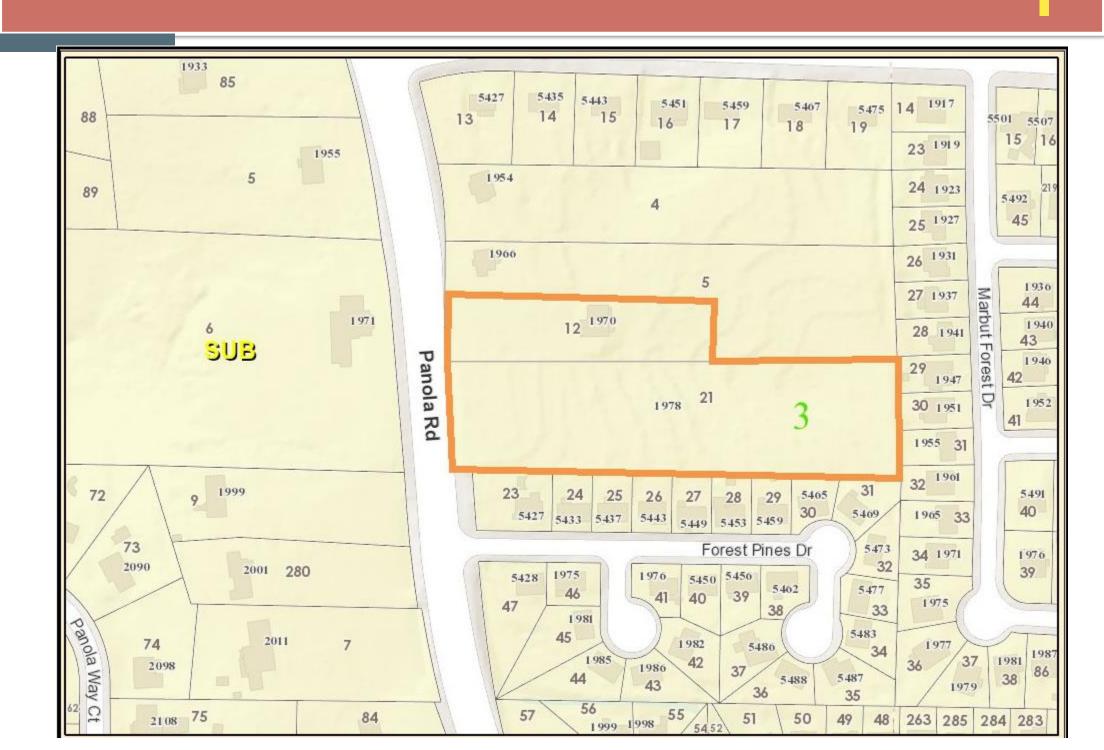


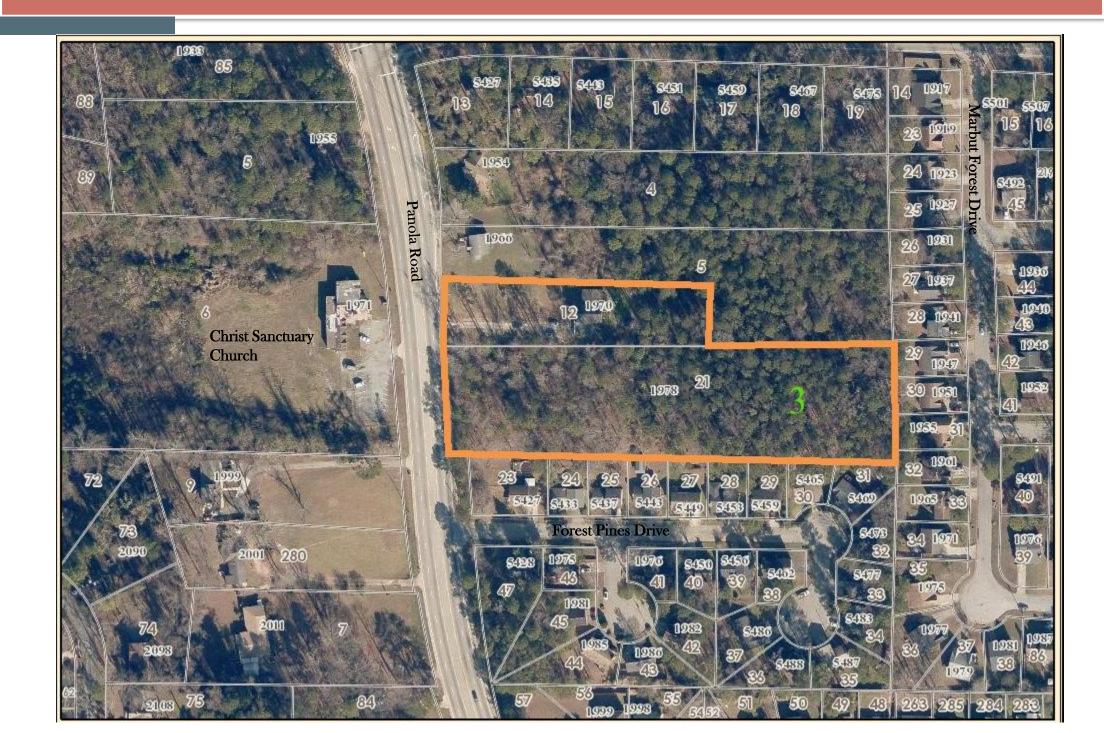
Z-19-1243514 Long Term Landscape Plan
